- 2. Schedule A Scope of Services is amended to include additional services required for Jones College Prep Academy to perform ALTA Survey Services. The scope for this service is detailed in Attachment A to this Amendment 1.
- 3. Schedule C Compensation of the Consultant is revised as follows:
  - C.1 The Consultant shall be paid the not to exceed amount of \$3,550.00 for the additional services outlined in Attachment B of this Amendment 1.

The Not to Exceed Fee is increased to a total of \$7,800.00.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.

The terms of the Agreement remain in full force and effect except as modified in this Amendment.

## ATTACHMENT A SCOPE OF WORK

## ALTA SURVEY SERVICES JONES COLLEGE PREP ACADEMY PROJECT NO.: 05265 CONTRACT NUMBER PS 1502

The Scope of Services includes but is not limited to the following tasks:

- Provide spot elevations along property line at twenty-five (25) foot intervals;
- Provide spot elevations at alley lot line and low point at twenty-five (25) foot intervals;
- Locate RCN line in alley and confirm location of telecommunications manhole. Confirm RCN line runs the length of the alley;
- · Locate underground water tunnel that runs across the property;
- Locate all doors and entrances along the existing buildings along the alley;
- · Confirm sign and parking bay box locations along State Street;
- Locate crossing striping, depressed curb and ADA tiles; and
- Designation of CTA bus stop sign on the West side of State Street that should be referenced in the survey.



I have reviewed the comment letter from Chris Hale of Perkins + Will, dated May 19, 2010 and received by us on May 28th. Our fee to provide the additional information requested in said letter would not exceed \$2,500.00. The survey would include the current ALTA/ACSM certification as in use on the plat and the same Table A items. The parties to be included in the certification would be provided by you at the time the order was placed or soon thereafter. The survey would include all additional information requested by Mr. Hale, except items 3 and 4. In order to locate the "RCN" line and the water tunnel, these would have to be marked on the ground by DIGGER or another utility locating service. Said water tunnel and "RCN" line would have been depicted had they been available from our previous Board of Underground request. Should it be required to re-order City of Chicago Board of Underground information, there would be an additional fee of \$300.00. We will provide 12 signed, sealed and embossed prints of the plat.
