Members of the Board of the Public Building Commission:

I am pleased to provide you with the Public Building Commission's Quarterly Staff Report. The report is intended to communicate current project status and performance metrics on a regular basis. Because these reports offer cumulative performance data, this report reflects year-to-date statistics and accomplishments through Q3 2015.

As a public developer, we are entrusted with public resources and we understand the importance of this responsibility. This report reflects the highest level of accountability and transparency in managing and reporting how we spend these taxpayer-supported dollars.

The support we receive from our clients and community partners, and our cost and schedule controls, have allowed us to build upon a track record of completing projects on schedule and within budget. These projects have helped to stabilize neighborhoods and serve as a catalyst for more development that has reshaped and revitalized our communities.

Through the 3rd Quarter of 2015, we completed seven projects on behalf of Chicago Public Schools, successfully delivering three new additions, modular units at two schools and air conditioners at 35 schools across the city. Our work on behalf of CPS helps to ease overcrowding and provide 21st century learning environments for students, giving them the environment they need to succeed and thrive.

We also marked the completion of the Chinatown Branch Library, which has quickly become an important community anchor that serves as a vibrant hub for the neighborhood.

These projects also have had a broader economic impact on the people who call these neighborhoods home because of the jobs created. The PBC is committed to economic sustainability and a diverse workforce that reflects the communities we serve and we are always striving to increase business participation on our projects.

We are also strongly committed to environmental sustainability and thanks to your leadership and advocacy, elements of sustainable design are included in every project we build.

The projects we develop in close partnership with our clients are as diverse as the communities we serve. We currently have a portfolio of 12 active capital projects, including two new elementary schools and five school additions or modernizations. Our work also includes energy and technology projects across



the city and Cook County. Below you will find an overview of what is included in this report.

Executive Summary Report

Below are the highlights from the Q3 2015 Quarterly Staff Report

1. Executive Summary Report

The details included in Q3 2015 Staff Report are intended to communicate project status and performance metrics on PBC projects. The metrics are reported quarterly, culminating in the Year End Staff Report published each year.

2. Program Cost Performance

The PBC is committed to cost efficient delivery of our projects. We manage costs over the life of the project and work closely with our clients throughout the development of a project to ensure that only the funds necessary to complete a project are needed.

Multi-Year Program Cost Status Report

As of Q3 2015, the PBC's multi-year program authority exceeds \$1.78 billion for projects complete or in progress since 2011. Projects included in the multi-year program are trending under budget by **9.13%** representing a variance of **\$160** million under the current budgets, inclusive of a limited number of scope revisions.

The PBC's budget to actual variance on active capital construction projects is 2.02%

3. Program Cost Effectiveness Report

In addition to managing projects to approved budgets and delivering projects as good stewards of the public funds, the PBC also focuses on the management of change orders and indirect project costs to maximize cost effectiveness.

Construction Change Order Report

The approved Change Order % for recently completed projects and those currently in construction is **1.6%**. The projected change order % for these projects is **2.6%**. Projected Change Orders include those currently in process for approval as well as forecasted potential change orders. These rates are within the industry standard change order percentage of 3-5% for new municipal and educational construction work. The PBC's current program also includes renovation projects, which typically have a higher change order percentage than new construction.

Indirect Costs as a Percentage of Construction Costs

The PBC tracks all project costs throughout the life of a project, including Indirect Costs, also known as "soft costs" (Planning, Design Program and Project Management, Environmental Testing & Consulting) as well as all Construction Costs, also known as "hard costs" (Demolition, Site Prep, Utility Relocation, and General Construction.)



The PBC's Indirect Costs average **16.82%** of construction. This is consistently below the industry average of 25%.

Indirect Costs are particularly cost effective on large scale projects and programs. The PBC averages 13.63% of construction costs on projects where construction is \$50M or higher, 16.21% on projects where construction is \$20M-50M, and 23.52% on projects where construction is \$1M-\$20M. The larger the project, the lower the indirect costs.

Market Conditions Report

This report illustrates comparative costs of like buildings, thereby tracking market trends.

4. Program Forecast and Project Status Report

This report provides a detailed snapshot and look ahead of active projects and is sent to elected officials and other stakeholders monthly to provide current progress.

5. Environmental Sustainability Report

The PBC achieved LEED certification on its 70th project in the third quarter of 2015: Chicago Children's Advocacy Center (LEED Gold).

Through Q3 2015, PBC had achieved LEED Certification on **70** facilities, bringing the total number of LEED-certified, municipally-owned facilities to **90**. This surpasses Mayor Emanuel's goal of doubling the number of LEED-certified municipal buildings in the City more than a year ahead of schedule.

Additionally, the PBC remains committed to renewable energy strategies. To date, PBC has installed geothermal systems at 16 buildings, installed 75 solar thermal panels at 6 buildings, and building integrated photovoltaics or panels at 2 buildings with another 5 buildings made PV-ready.

6. Economic Sustainability Report

The PBC is committed to economic sustainability and includes provisions for Minority and Women Owned Business (M/WBE) Participation and Workforce (Equal Employment Opportunity) goals in our contracts. M/WBE and EEO Commitments and Hiring Goals are reported to the Board at the time of contract award. The PBC tracks compliance throughout the life of a project on both Construction and Professional Services contracts.

M/WBE Compliance for Projects Completed in Q3 2015

A combined total of 41.04% M/WBE Participation has been achieved on twelve capital construction projects completed as of the third quarter: Chicago Children's Advocacy Center Addition, Chicago Vocational Career Academy Renovations, Chinatown Branch Library, CPL YOUMedia Renovations at Legler, Sulzer, and Woodson, CPS 2015 Air Conditioner Project (35 Facilities), Lincoln Elementary School Annex, Mt. Greenwood Elementary School Modular, Oriole Park Elementary School Annex, Tonti Elementary School Modular, Turf Field at National Teacher's Academy, Wildwood World Magnet School Annex, and Woodson Regional Library Lighting & Ceiling Renovations.

In addition to project level professional services, the PBC also tracks compliance on program-wide professional administrative services. These professional services are not project specific and include but are not limited to: Financial Services, Information Technology, Insurance Broker Services, Legal / IG, Office Management, Payroll, Staffing, and Property Management.

M/WBE Compliance Report for Professional Administrative Services Paid in 2015 A combined total of **58.12%** M/WBE Participation was achieved on professional administrative services paid through Q3 2015.



The new Chinatown Branch Library replaces the existing branch library with a new facility at the southwest corner of the Wentworth and Archer intersection. The new, 16,370 square foot two story branch library serves as cultural and information center to visitors to the area and includes community branch program elements such as a large reading room, a YOUmedia digital media space for teens, an expanded community room, children's reading room, meeting space for community use, state of the art technology, Wi-Fi, and self-checkout stations. The building incorporates several sustainability measures including energy efficient building systems, water use reduction measures, native plantings, and permeable pavement that contribute to the pursuit of LEED Certification.

Sustainability Program

In line with its mission and vision, the Public Building Commission of Chicago (PBC) has developed 70 LEED certified facilities, with an additional 18 LEED registered projects in development, and is managing programs to install Energy Conservation Measures across a broad range of City of Chicago and Metropolitan Water Reclamation District (MWRD) facilities. The PBC is also pioneering the integration of Green Remediation into project development, in line with the PBC and City of Chicago sustainability agenda. Together, the City of Chicago and Sister Agencies, including the PBC have achieved LEED Certification on 90 municipally owned facilities. The June 2011 commitment to double the number of LEED certified facilities was achieved in the first quarter of 2014, well ahead of schedule.

Additionally, the PBC remains committed to renewable energy strategies. To date, PBC has installed geothermal systems at 16 buildings, installed 75 solar thermal panels at 6 buildings, and building integrated photovoltaics or panels at 2 buildings with another 5 buildings made PV-ready.

The Daley Center achieved LEED EB O+M Silver certification in May 2012. The PBC sought LEED EB O+M certification to align with overall sustainability goals, and demonstrate that LEED EB O+M can be achieved in municipally-owned, large assembly use buildings. The Daley Center continues to have performance benefits that resulted from the work that was undertaken in pursuit of Energy Star, LEED EB O+M, and the Guaranteed Performance Contracts.

Multi-Agency Energy Performance Contract Program

PBC is managing a multi-agency energy performance contract program, utilizing Energy Service Companies (ESCOs) to reduce energy use and carbon footprint across the City of Chicago and Cook County. The program is designed to leverage long term utility savings to pay for energy-related capital improvements. ESCOs are deployed to identify, design, implement and guarantee the performance of Energy Conservation Measures (ECMs) - that achieve significant long term savings that can be measured and verified. ECM projects can be financed with no capital outlay. Rebates and other incentives may also be accessed to supplement project funding. The program is currently underway in two forums: Retrofit Chicago and MWRD/PBC Energy Efficiency Program.

Retrofit Chicago

Out of an initial list of 238 City of Chicago facilities, an initial feasibility analysis on 148 buildings was completed in November 2012. Investment Grade Energy Audits were performed on 112 of these facilities, and 60 buildings were ultimately identified as suitable candidates for inclusion in Retrofit One, the first phase of Retrofit Chicago. Retrofit One, a \$12.8M project, approved by City Council on January 15, 2014, is guaranteed to save at least \$1.4 million in annual utility energy costs, with additional operations and maintenance benefits also expected. Project implementation, undertaken by three ESCOs, commenced April 2014 and was substantially completed in June 2015. As-built savings reports are currently being tabulated and reviewed in preparation of the guaranteed performance period. The first energy savings verification reports are expected in the 1st quarter of 2016.

MWRD / PBC Energy Efficiency Program

A preliminary feasibility study was completed to assess opportunities for implementing ECMs across Metropolitan Water Reclamation District (MWRD) wastewater treatment plant buildings. Three ESCO's analyzed the Terrance O'Brien Wastewater Treatment Plant in Skokie, Illinois. Based on their feasibility analyses, an MWRD evaluation committee recommended that MWRD proceed with the next phase of the planning process. In March 2014, the MWRD Board of Commissioners granted approval for the PBC to lead a full audit process. One ESCO was selected to perform Investment Grade Audits of all MWRD treatment plant buildings. The final Investment Grade Audit Report was submitted to senior MWRD executives in April 2015. The PBC is expected to receive MWRD and PBC board approval in 2015 to proceed with the implementation of a \$13 million project. Construction activities are expected to be completed in phases.

Green / Sustainable Remediation

PBC has taken a leadership role in the state of Illinois, in the region, and across the United States in implementing green and sustainable remediation (GSR) as a key part of the project development process. GSR Best Management Practices was first explored as a cost saving strategy: Soil management plans and in-situ remediation provide ways to reduce waste haul off, and to mitigate soil contamination levels at the site, and in material that must be removed, protecting both worker and community health and safety. GSR aligns well with the City's and PBC's sustainability agenda, and helps to contribute to the development of new community anchors. PBC collaborated with IL EPA in support of its Green Remediation Guideline, and the new ASTM 2893 Standard Guide for Greener Cleanups, for which one PBC project is now a case study. It also allowed PBC access to US EPA grants and IL EPA revolving loan funds earmarked to support the development of GSR.

An ancillary benefit has been the opportunity to win awards, and to share what we have learned through speaking engagements, and further collaboration. To date, PBC has presented at multiple conferences, sharing case studies and practices with the sustainability, design, construction management and environmental communities, and has won several awards for our program.

Next steps are to continue to use and support the new ASTM standard and IL EPA guide, and to start compiling SEFA (Spreadsheets for Environmental Footprint Analysis) analyses for future projects, to understand in hard metrics the energy and air quality impacts of GSR on PBC projects.





Total MBE/WBE Participation













Total MBE/WBE Participation (All Regions)






