#### FINDING BID OPPORTUNITIES

The PBC issues all procurement opportunities online under PBC Alerts, sign up at www.pbcchicago.com.

#### **PRE-BID MEETINGS**

Pre-bid meetings are an excellent opportunity for sub-contractors to meet the General Contractors who are bidding on a project. The website will let you know the details about bidding opportunities, including the time and location of any pre-bid meetings.

#### PRE-QUALIFICATION PROCESS

The PBC will evaluate qualifications based on information provided in the "Statement of Qualifications and Financial Condition," including required attachments and performance references. Firms deemed eligible for pre-qualification will be placed on the appropriate notification list for specific projects. Notices will be sent to pre-qualified firms when the project opportunities arise. All firms are required to have a City of Chicago and General Contractors license and all other required licenses for the type of work under consideration.

### Commitment to Economic Sustainability Programs for the Community

Current procurements and resultant contracts have 6 robust economic sustainability provisions:

- Bid incentives for the employment of minority and female workers
- Bid incentives for the employment of apprentices
- Contract provisions that require at least 50% of the labor force be local residents
- Contract provisions that require community hiring, helping to employ those closest to the work at hand
- Contract provisions that require minorityand women-owned business participation
- Contract provisions for local business participation

### economic sustainability

#### CHICAGO PUBLIC SCHOOLS

#### Air Force Academy Renovation (Phase II)

Tentative Bid Date: January 2011

This project converts the former Abbott Elementary School into a military high school. The scope of work includes ADA accessibility upgrades (elevator, stage lift, exterior ramps, and full toilet room renovations), warming kitchen renovation, two science labs, locker rooms, interior finish repairs, lighting replacement and retrofit, roof replacement, exterior window replacement, asbestos abatement, and landscape upgrades.

#### Back of the Yards High School (Vertical Construction)

Tentative Bid Date: January 2011

This project will implement the CPS Urban Model High School (UMHS) prototypical design to serve 1,200 students. This 200,000 SF, three-floors plus lower level, steel frame and masonry construction building will include music, art, and athletic functions.

#### Collins High School Renovation

Tentative Bid Date: January 2011

Scope includes conversion of an auto shop into a library/media center and postsecondary education spaces, interior classroom finishes throughout the Arts Building, new lighting and sound system for the auditorium, new filtration system for swimming pool and landscape at both main entry plazas.

#### Edgebrook Elementary School Addition

Tentative Bid Date: April 2011

Scope of this project is an addition to the existing school, containing 8 classrooms, a warming kitchen and lunchroom, a science classroom, restrooms, storage and circulation.

#### CHICAGO PUBLIC LIBRARIES

#### Edgewater Branch Library

Tentative Bid Date: November 2011

Based on a new Prototype "C" design, this new 18,665 SF, two-story full service branch library will replace the existing Edgewater Branch Library at the same location.

#### CHICAGO FIRE DEPARTMENT

#### **Engine Company 16**

Tentative Bid Date: January 2011

This new 19,725 SF fire house will be constructed on the city-owned property at 3901 South Wabash Avenue. It will be a modified Prototype 'B' engine company with a Hazmat Unit, and include the following components: a large apparatus bay to house multiple emergency vehicles, full kitchen, locker rooms, toilet facilities, sleeping quarters, officers quarters, physical training room, meeting room, education room, EMS Field Division South offices, a 150' communication tower, and parking for approximately 30 vehicles.



#### CHICAGO PARK DISTRICT

#### **Gateway Harbor**

Tentative Bid Date: March 2011

Located at Dime Pier at the mouth of the Chicago River just south of Navy Pier. The scope includes encapsulating Dime Pier; building approximately 235 boat slips; new finger docks on the south side of Navy Pier for commercial vessel use; installation of approximately one acre of land fill to build a harbor facility.

Recognizing the need for professional management of public construction projects, Mayor Richard J. Daley in 1956 formed the Public Building Commission of Chicago to develop quality government facilities, an important goal that continues to be at the heart of the organization. Today, PBC chairman Mayor Richard M. Daley is joined by 10 other Chicago business and civic leaders whose dedication to the city and its communities has led them to volunteer their time.

PBC clients include the City of Chicago, Cook County, the Chicago Public Library, the Chicago Public Schools, the Chicago Park District and the City Colleges of Chicago. The PBC professional staff manages each project through planning, design and construction, functioning as an important link between clients and contractors.

The PBC's first major construction project was the Chicago Civic Center, which continues to be its headquarters. Started in 1963 and opened in 1966, it was re-dedicated the Richard J. Daley Center in 1976 to honor the late mayor shortly after his death. Heralded around the country as an architectural gem, the open, modern design of the Daley Center revolutionized government structures in Chicago and throughout the nation.

A year after the Civic Center was completed, the City of Chicago commissioned Pablo Picasso to create a steel sculpture to grace the facility's grand plaza. This work of art helped establish the Daley Center as one of Chicago's most important architectural landmarks and has become a distinctive symbol of the city itself.






