The reading of the minutes of the March 1, 2018 Administrative Operations Committee meeting, which was previously distributed, was dispensed with. Upon motion duly made and seconded the minutes were unanimously adopted.

The Executive Director provided a report on a bid opening for the Group B Renovation Projects for the Chicago Park District.
