THIS THIRD AMENDMENT AGREEMENT is made and entered into as of the 16th day of December, 2010, and shall be deemed and taken as forming a part of the Agreement for LAN/Desktop Support Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **UNISYS CORPORATION** ("Unisys") dated February 13, 2004 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Unisys have heretofore entered into an Agreement dated the 13th day of February, 2004, ("Agreement") wherein Unisys is to provide LAN/Desktop Support Services for the Commission; and

WHEREAS, the Commission and Unisys now desire to amend the Agreement to include Additional Services performed and associated compensation due to Unisys;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. Term

The Services of Unisys is extended an additional forty-eight (48) months from December 2, 2010 through December 1, 2014.

3. Unisys' Fee

The fee for Services will be \$69.76 per seat per month. Current seat count is 64 seats and may be adjusted by the Commission. Any Adjustments to the seat count will modify the compensation per the terms of the original Agreement.

Unisys' compensation is on a monthly basis. The compensation fee is increased by a not to exceed amount of \$214,302.72.

Execution of this Amendment by the Consultant is duly authorized by Unisys, and the signature(s) of each person signing on behalf of Unisys have been made with the complete and full authority to commit Unisys to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.

The terms of the Agreement remain in full force and effect except as modified in this Amendment.
