

**FOURTH AMENDMENT  
DESKTOP/LAN SUPPORT SERVICES  
CONTRACT NUMBER PS 743  
PROGRAM-WIDE**

THIS FOURTH AMENDMENT AGREEMENT is made and entered into as of the 9th day of December 2014, and shall be deemed and taken as forming a part of the Agreement for LAN/Desktop Support Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **UNISYS CORPORATION** ("Consultant") dated February 13, 2004 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Unisys have heretofore entered into an Agreement dated the 13<sup>th</sup> day of February 2004, wherein Unisys is to provide LAN/Desktop Support Services for the Commission; and

**WHEREAS**, the Commission and Unisys now desire to amend the Agreement to include Additional Services performed and associated compensation due to Consultant;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

**TERMS**

1. **Recitals**  
THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.
2. **Schedule A      Scope of Services**
  - 2.1 This FOURTH AMENDMENT is an extension of the existing Desktop/Lan Support Services contract through November 30, 2015.
3. **Schedule D      Compensation of the Consultant**
  - 3.1 The Compensation paid to Unisys under this agreement is \$70,318.08 per year, which represents 84 seats at \$69.76 per seat per month (totaling \$5,859.84 per month); which represents a per seat cost of services as part of using the City of Chicago contract.

Execution of this Amendment by Consultant is duly authorized by the Unisys and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.

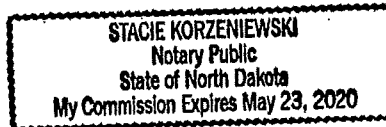
