**PROFESSIONAL SERVICES AGREEMENT**

**AGREEMENT NO. PS-910**

This agreement, dated as of the **October 3, 2005**, but actually executed on the date witnessed hereinbelow, by and between the **Public Building Commission of Chicago**, a municipal corporation of the State of Illinois, having its principal office at Room 200, Richard J. Daley Center, 66 West Washington Street, Chicago, Illinois 60602, referred to in this Agreement as the "**Commission**", and **Willis of Illinois, Inc.**, with offices at 10 South LaSalle, Suite #3000, Chicago, Illinois 60603 referred to in this Agreement as the "**Consultant**",

**WITNESSETH:**

WHEREAS, the Commission requires certain professional services, described on Schedule A to this Agreement (the "Services"), in connection with Insurance Brokerage Services and desires to employ the Consultant, on the terms and conditions set forth in this agreement, to perform such Services; and

WHEREAS, the Consultant desires to be so retained by the Commission and has represented to the Commission that the Consultant has the knowledge, skill, experience and other resources necessary to perform the Services in the manner herein provided; and

WHEREAS, the Consultant has consulted with the Commission, reviewed the Documents (defined below) and taken such other actions as the Consultant has deemed necessary or advisable to familiarize itself with the scope and requirements of the Project and the Services;

NOW, THEREFORE, for valuable consideration, the Commission and the Consultant agree as follows:

1. Incorporation of Recitals. The matters recited above are hereby incorporated in and made a part of this agreement.
2. Definitions. The following phrases have the same meanings for purposes of this Agreement:
  - a. **Agreement** means this professional services Agreement, including all exhibits or documents attached hereto and/or incorporated by reference herein, and all amendments, modifications, or revisions made in accordance with the terms hereof.
  - b. **Commission** as herein referred to shall include the Commission's Chairman, Secretary, Assistant Secretary, Executive Director, Chief of Staff, Director of Construction, Managing Architect, Director of Procurement, Risk Manager, or designated consultant or consultants, acting on behalf thereof, as designated by the Commission in writing, for the purpose of giving authorizations, instructions, and/or approval pursuant to this Agreement.

- c. **Contract Documents** consists of all of the component parts of the Contract between the Commission and the insurer(s), including but not limited to any memorandums of understanding, binders, agreements, policies or modifications thereto.
- d. **Consultant**, also referred to as Insurance Broker or Broker, means the company, insurance broker or other entity identified in this Agreement as the party providing these services to the Commission, and such successors or assigns, if any, as may be authorized by the terms and conditions of this Agreement.
- e. **Key Personnel** means those job titles and persons as identified in those positions as identified in the Consultant's proposal and accepted by the Commission.
- f. **Program** means the system of insurance agreed upon by the Consultant and the Commission as the most effective means of protecting the Commission, its assets and those operations in which the Commission bears an interest.
- g. **Services** means collectively, the services duties and responsibilities that are necessary to allow the consultant to provide the Services required by the commission under this Agreement. The required Services are described in Schedule A of this Agreement.
- h. **Sub-consultant** means a firm hired by the Consultant to perform professional services related to the program.
- i. **Technical Personnel** as herein referred to include partners, officers and all other personnel of the Consultant, including technical typists assigned to the Project, exclusive of general office employees.

3. Incorporation of Documents. The documents identified below in this paragraph are hereby incorporated in and made a part of this Agreement. By executing this Agreement, Consultant acknowledges and agrees that Consultant is familiar with the contents of each of such documents and will comply fully with all applicable portions thereof in performing the Services.

a. Program Documents. The analyses, reports, recommendations and conclusions regarding the program, including but not limited to quotations, asset listings, as set forth and described in the Scope of this Agreement.

b. Policies Concerning MBE and WBE. The Commission's policies concerning utilization of minority business enterprises ("MBE") and women business enterprises ("WBE"), as the same may be revised from time to time.

4. Engagement and Standards for Performing Services.

a. Engagement. The Commission hereby engages the Consultant, and the Consultant hereby accepts such engagement, to provide the Services described in Schedule A to this agreement. The Services may be amended from time to time by mutual agreement of the Commission and the Consultant.

b. Nondiscrimination. The Consultant agrees that in performing this Agreement it shall not discriminate against any worker, employee or applicant for employment, or any member of the public, because of race, creed, gender, color, national origin or disability, or otherwise commit an unfair labor practice. Attention is called to applicable provisions of the Civil Rights Act of 1964, 88-352, July 2, 1964, 78 Stat. 241 et. Seq. the Americans with Disabilities Act of 1990, 42 U.S.C. 12010 et. Seq. the Illinois Human Rights Act 775 ILCS 5/1-101 et. Seq. and the Public Works Employment Discrimination Act 775 ILCS 10/0.01 through 10/20, inclusive and a Resolution passed by the Board of Commissioners of the Public Building Commission of Chicago on February 11, 1992, concerning participation of Minority Business Enterprises and Women Business Enterprises on contracts awarded by the Commission. The Consultant will furnish such reports and information as requested by the Commission and the Illinois Department of Human Relations or any other administrative or governmental entity overseeing the enforcement, administration or compliance with the above referenced laws and regulations.

c. Employment Procedures, Preferences and Compliances. Salaries of employees of Consultant performing work under this Agreement shall be paid unconditionally and not less often than once a month without deduction or rebate on any account except only such payroll deductions as are mandatory or permitted by the applicable law or regulations. Attention is called to Illinois Compiled Statutes, 1992 relating to Wages and Hours including 820 ILCS 130/0.01 through 130/12 thereof (Prevailing Wage Act), 30 ILCS 570/1 through 570/7 (Employment of Illinois Workers on Public Works Act) and 30 ILCS 560/0.01 through 560/7 (Public Works Preference Act). The Consultant shall comply with all applicable "Anti-Kickback" laws and regulations, including the "Anti-Kickback" Act of June 13, 1934 (48 Stat. 948; 62 Stat. 740; 63 Stat. 108; 18 U.S.C. § 874; 40 U.S.C. § 276c) and the Illinois Criminal Code of 1961 720 ILCS 5/33E-1 et. seq. If, in the performance of this Agreement, there is any direct or indirect kickback, the Commission shall withhold from the Consultant, out of payments due to it, an amount sufficient to pay employees underpaid the difference between the salaries required hereby to be paid and the salaries actually paid such employees for the total number of hours worked. The amounts withheld shall be disbursed by the Commission for and on account of the Consultant to the respective employees to whom they are due.

d. Compliance with Policies Concerning MBE and WBE. Without limiting the generality of the requirements of the policies of the Commission referred to in paragraph 2 above, the ~~LEED & Commissioning~~ Consultant will use every reasonable effort to utilize minority business enterprises for not less than twenty five percent (25%) for MBE and five percent (5%) for WBE of the value of the Services, in accordance with the Resolution passed by the Board of Commissioners of the Commission on October 1, 2004, concerning participation of minority

business enterprises and women business enterprises on contracts awarded by the Commission and to furnish to the Commission, such reports and other information concerning compliance with such Resolution as may be requested by the Commission from time to time.

e. Delays. The Consultant agrees that no charges for damages or claims for damages shall be asserted by it against the Commission for any delays or hindrances from any cause whatsoever during the progress of any portion of the Services. Such delays or hindrances, if any, shall be compensated for by an extension of time to complete the Services, for such reasonable period as may be mutually agreed upon between the parties, it being understood, however, that the agreement of the Commission to allow the Consultant to complete the Services or any part of them after the time provided for the completion thereof herein shall in no way operate as a waiver on the part of the Commission of any of its rights hereunder.

f. Records. The Consultant shall maintain accurate and complete records of expenditures, costs and time incurred by Consultant in connection with the Services. Such records shall be maintained in accordance with recognized commercial accounting practices. The Commission may examine such records at Consultant's offices upon reasonable notice during normal business hours. Consultant shall retain all such records for a period of not less than five calendar years after the termination of this agreement.

g. Time of Essence. The Consultant acknowledges and agrees that time is of the essence in the performance of this Agreement and that timely completion of the Services is vital to the Commission. Consultant agrees to use its best efforts to expedite performance of the Services and performance of all other obligations of the Consultant under this Agreement and any other agreements entered into by the Commission which are managed or administered by the Consultant as a result of the Consultant's engagement hereunder.

Notwithstanding the foregoing, the Consultant does not guarantee or make any representation or warranty the insurance can be placed on terms proposed by the Commission.

h. Compliance with Laws. In performing its engagement under this Agreement, the Consultant shall comply with all applicable federal, state and local laws, including but not limited to, those referenced in subparagraphs (b) and (c) above and in the documents referred to in paragraph 3 of this agreement.

i. Progress Meetings. Meetings to discuss the program and/or to review the performance of the Consultant may be scheduled upon the Commission's request, at mutually agreeable times and locations, and the Consultant agrees to cause such meetings to be attended by appropriate personnel of the Consultant engaged in performing or knowledgeable of the Services.

j. Defects in Services. The Consultant shall notify the Commission immediately in the event the Consultant obtains knowledge of a defect or circumstances that could result in a Service delay or cost overrun.

k. Performance Standard. The Consultant represents and agrees that the Services performed under this Agreement will proceed with efficiency, promptness and diligence and will be executed in a competent and thorough manner, in accordance with reasonable professional standards in the field. The Consultant further agrees that it will assign to the engagement at all times during the term of this Agreement the number of experienced, appropriately trained employees necessary for the Consultant to perform the Services in the manner required hereunder.

l. Changes (Amendments). The Commission may from time to time, request changes to the terms of the Agreement or in the Scope of Services of the Consultant to be performed hereunder. Such changes, including any increase or decrease in the amount of compensation and revisions to the duration of the Services, which are mutually agreed upon by and between the Commission and Consultant, shall be incorporated in a written amendment to this Agreement. The Commission shall not be liable for any changes absent such written amendment.

m. Copyright Infringement. Consultant represents and warrants to the Commission that (i) that Consultant is the owner of numerous proprietary programs and documents that may be deemed "Literary Works" within the meaning and purview of Section 101 of the United States Copyright Act (17 U.S.C. Sec. 101 et. seq.) (The "Copyright Act"); (ii) that the Literary Works do not infringe or otherwise violate any copyright, patent, trade secret or any other intellectual property right that is protected by the Copyright Act; (iii) Consultant will notify the Commission promptly in writing in the event the Consultant receives notice of any claim which alleges that the Literary Works under by the Consultant in performing the Services under this Agreement violate the provisions of the Copyright Act; and (iv) Consultant will indemnify, defend and hold the Commission harmless from any claim or proceeding to the extent that it is based upon a claim that the Literary Works used with the scope of this Agreement infringe upon a patent or copyright, misappropriate a trade secret or otherwise violate the Copyright Act.

n. Insurers.  
The Consultant shall be authorized for purposes of this agreement to represent and assist the Commission in all discussions and transactions with all insurers, provided that the Consultant shall not place any insurance on the Commission's behalf unless so authorized. The Consultant will monitor published financial information of the current insurers used hereunder and alert the Commission when the status of one or more of such insurers falls below the Consultant's minimum financial guidelines. The Consultant will not, however, be responsible for the solvency or ability to pay claims of any insurance carrier. Insurers with whom risks are placed hereunder will be deemed acceptable to the Commission, in the absence of contrary written instructions from the Commission.

5. Term.

a. The term of this Agreement shall begin on the Commencement Date of Services specified in Schedule A to this Agreement, and subject to the provisions of subparagraph (b) below, shall expire upon completion of Services and acceptance thereof by the Commission or, if the Services are of an ongoing nature, on the Completion Date of Services specified in Schedule

A. The Commission and the Consultant may, from time to time, by mutual agreement, extend the term of this Agreement by amending Schedule A hereto.

b. The Commission shall have the right, at any time, to terminate the term of this Agreement, with or without cause, by written notice given to the Consultant at least 30 days prior to the effective date of termination. In addition, the Commission shall have the right, at any time and from time to time, with or without cause, to suspend the performance of the Consultant hereunder with respect to all or any part of the Services, by written notice given to the Consultant at least 5 days prior to the effective date of suspension. Termination or suspension of this Agreement shall not relieve the Consultant from liability for the performance of any obligation of the Consultant under this Agreement performed or to have been performed by the Consultant on or before the effective date of termination or suspension. Provided the Consultant is not in default under this Agreement at the time of termination or suspension, the Commission agrees to pay to the Consultant, in accordance with the following schedule: **Fees will be paid 50% when liability coverage is bound and 50% when property coverage is bound.**

In no event shall the Commission be liable to the Consultant for any loss, cost or damage which the Consultant or any other party may sustain by reason of the Commission terminating or suspending this Agreement as provided herein; provided, however, that the Commission may, in its sole discretion, reimburse the Consultant for actual expenses approved by the Commission.

In the event of an early termination of this Agreement as provided herein, or upon expiration of this Agreement, the Consultant will assist the Commission in arranging a smooth transition process; however, the Consultant's obligation and the obligation of its affiliates to provide services to the Commission will cease upon the effective date of termination or expiration

c. If the engagement, in whole or substantial part, is stopped for a period longer than 30 days under an order of any court or other governmental authority having jurisdiction of the Project, or as a result of an act of government, such as a declaration of national emergency making materials unavailable, through no act or fault of the Consultant, or if the Commission fails to make any payment or perform any other obligation hereunder, the Consultant shall have the right to terminate this agreement, by written notice given to the Commission at least 7 days prior to the effective date of termination, and shall have the right to recover from the Commission all compensation and reimbursements due to the Consultant for periods up to the effective date of termination.

6. Compensation of Consultant; Reimbursement for Expenses. The Commission shall compensate the Consultant for the Services in the manner set forth on Schedule C to this Agreement.

In certain cases, placement which the Consultant makes on the Commission's behalf may require the payment of surplus lines taxes and/or fees to state regulators, boards or associations, which the Commission agrees to pay. Such taxes will be identified on invoices covering these placements.

The Consultant may utilize the services of other intermediaries to assist in the marketing of the Commission's insurance (including brokers in the London and other markets), when in the Consultant's professional judgment it is necessary and appropriate. Such intermediaries may or may not be affiliates of the Consultant. The compensation of such intermediaries is not included in the Consultant's compensation hereunder and will; be paid by insurers out of paid premiums.

7. Rights and Obligations of Commission. In connection with the administration of the Project by the Commission and the performance of this Agreement by the Consultant, the Commission shall have the following rights and obligations, in addition to those provided elsewhere in this agreement:

a. Information. The Commission shall provide the Consultant all reasonably requested information concerning the Commission's requirements for the Program and the Services.

The Consultant will assist the Commission with documentation and other steps to obtain commitments for and implement the Commission's insurance program upon the Commission's instructions; it is understood that the Consultant will not independently verify or authenticate the Commission-provided information necessary to prepare underwriting submissions and other documents relied upon by insurers.

b. Review of Documents. Subject to the provisions of subparagraph 4(e) above, the Commission agrees to make a reasonable effort to examine documents submitted by the Consultant and render decisions pertaining thereto with reasonable promptness.

c. Site Data. To the extent the Commission determines to be necessary for the Consultant to perform the Services, the Commission may furnish, or may authorize the Consultant to obtain from a company or companies approved by the Commission as Reimbursable Expenses: information concerning locations, dimensions and data pertaining to existing buildings and other improvements.

d. Designated Representatives. The Commission may designate, at its sole discretion, one or more representatives authorized to act in its behalf.

e. Ownership of Documents All documents, studies and reports prepared by the Consultant hereunder shall remain the property of the Commission including copyrights as described in subparagraph 4(m) above (except for programs developed by the Consultant).

f. Audits. The Commission shall have the right to audit the books of the Consultant on all subjects relating to the Program and/or the Services for up to 5 years.

8. Indemnification of Commission. The Consultant hereby agrees to indemnify, keep and save harmless the Commission and its commissioners, board members, officers, agents, officials and employees from and against all claims, demands, suits, losses, costs and expenses, including but not limited to, the fees and expenses of attorneys, that may arise out of or be based on any injury to persons or property that is or is claimed to be the result of an error, omission or negligent act of the Consultant or any person employed by the Consultant to the maximum extent permitted by applicable law.

9. Insurance to be Maintained by Consultant. The Consultant shall purchase and maintain at all times during the performance of Services hereunder, for the benefit of the Commission and the Consultant, insurance coverage which will adequately insure the Commission and the Consultant against claims and liabilities which could arise out of the performance of such Services, including but not limited to, the insurance coverages set forth on Schedule D to this agreement.

10. Default.

a. Events of Default. Any one or more of the following occurrences shall constitute an Event of Default under this agreement:

b. Failure or refusal on the part of the Consultant duly to observe or perform any obligation or agreement on the part of the Consultant contained in this Agreement, which failure or refusal continues for a period of 10 days or such longer period as the Commission, in its sole discretion, may determine if such failure is not capable of being cured within such 10-day period after the date on which written notice thereof shall have been give to the Consultant by the Commission;

c. Any representation or warranty of the Consultant set forth herein or otherwise delivered pursuant to this Agreement shall have been false in any material respect when so made or furnished;

d. The Consultant becomes insolvent or ceases doing business as a going concern, or makes an assignment for the benefit of creditors, or generally fails to pay, or admits in writing its inability to pay, its debts as they become due, or files a voluntary petition in bankruptcy, or is adjudicated a bankrupt or an insolvent, or files a petition seeking for itself any reorganization, arrangement, composition, readjustment, liquidation, dissolution, or similar arrangement under any present or future statute, law or regulation relating to bankruptcy or insolvency, or files an answer admitting the material allegations of a petition filed against it in any such proceeding, or applies for, consents to or acquiesces in the appointment of a trustee, receiver, liquidator or other custodian of it or of all or any substantial part of its assets or properties, or if it or its principals shall take any action in furtherance of any of the foregoing; or

There shall be commenced any proceeding against the Consultant seeking reorganization, arrangement, readjustment, liquidation, dissolution or similar relief under any present or future statute, law or regulation relating to bankruptcy which is not vacated, stayed, discharged, bonded or

dismissed within 60 days thereof, or there shall be appointed, without the Consultant's consent or acquiescence, any trustee, receiver, liquidator or other custodian of Custodian or of all or any substantial part of the Consultant's assets and properties, and such appointment shall not have been vacated, stayed, discharged, bonded or otherwise dismissed within 60 days thereof.

e. Remedies. If an Event of Default shall occur and be continuing, then the Commission may exercise any right, power or remedy permitted to it by law or in equity and shall have, in particular, without limiting the generality of the foregoing, the right to terminate this Agreement upon written notice to the Consultant, in which event the Commission shall have no further obligations hereunder or liability to the Consultant except as to payment for Services actually received and accepted by the Commission through the effective date of termination. No courses of dealing on the part of the Commission or delay or failure on the part of the Commission to exercise any right shall operate as a waiver of such right or otherwise prejudice the Commission's rights, powers or remedies.

f. Remedies not Exclusive. No right or remedy herein conferred upon or reserved to the Commission is exclusive of any right or remedy herein or by law or equity provided or permitted, but each shall be cumulative of every other right or remedy given hereunder or now or hereafter existing at law or in equity or by statute or otherwise, and may be enforced concurrently therewith or from time to time.

#### 11. Disputes.

a. General. All disputes arising under, related to or in connection with the terms of this Agreement or its interpretation, whether involving law or fact or both, including without limitation questions concerning allowability of compensation, and all claims for alleged breach of contract, shall be presented in writing to the Executive Director of the Commission for final determination.

b. Procedure. Requests for determination of disputes will be made by the Consultant in writing specifically referencing this Section, and will include: 1) the issue(s) presented for resolution; 2) a statement of the positions of the Consultant 3) the facts underlying the dispute; 4) reference to the applicable provisions of the Agreement by page and section; 5) identify any other parties believed to be necessary to the resolution; and 6) all documentation which describes and relates to the dispute. Consultant will promptly provide the Executive Director with a copy of the request for determination of the dispute.

The Executive Director's decision may thereafter be reached in accordance with such other information or assistance as she or he may deem reasonable, necessary or desirable.

c. Effect. The Executive Director's final decision will be rendered in writing no more than 45 business days after receipt of the dispute unless the Executive Director notifies the Consultant that additional time for the decision is necessary. The Executive Director's decision will be conclusive, final, and binding on all parties. Consultant must follow the

procedures set out in this Section and receive the Executive Director's final decision as a condition precedent to filing a complaint in the Circuit Court of Cook County or any other court.

The Consultant will not withhold performance of any Services required by the Commission under this Agreement during the dispute resolution period. The Executive Director's written determination will be complied with pending final resolution of the dispute.

12. Confidentiality All Deliverables and reports, data, findings or information in any form prepared, assembled or encountered by or provided by Consultant under this Agreement are property of the Commission and are confidential, except as specifically authorized in this Agreement or as may be required by law. Consultant must not allow the Deliverables to be made available to any other individual or organization without the prior written consent of the Commission. Further, all documents and other information provided to Consultant by the Commission are confidential and must not be made available to any other individual or organization without the prior written consent of the Commission. Consultant must implement such measures as may be necessary to ensure that its staff and its sub-consultants are bound by the confidentiality provisions in this Agreement.

Consultant must not issue any publicity news releases or grant press interviews, and except as may be required by law during or after the performance of this Agreement, disseminate any information regarding its Services or the project to which the Services pertain without the prior written consent of the Commission.

If Consultant is presented with a request for documents by any administrative agency or with a subpoena duces tecum regarding any records, data or documents which may be in Consultant's possession by reason of this Agreement, Consultant must immediately give notice to the Commission with the understanding that the Commission will have the opportunity to contest such process by any means available to it before the records, data or documents are submitted to a court or other third party. Consultant, however, is not obligated to withhold the delivery beyond the time ordered by the court or administrative agency, unless the subpoena or request is quashed or the time to produce is otherwise extended.

13. Assignment. The Consultant acknowledges that the Commission is induced to enter into this Agreement by the personal qualifications of the principals, staff and employees of the Consultant and agrees, therefore, that neither this Agreement nor any right or obligation hereunder may be assigned by the Consultant, in whole or in part, without the prior written approval of the Commission. The Consultant further acknowledges that the Consultant has represented to the Commission the availability of certain members of the Consultant's staff who will be assigned to the engagement, and agrees, therefore, that in the event of the unavailability of such members due, the Consultant shall so notify the Commission in writing, and shall assign other qualified members of the Consultant's staff, as approved by the Commission, to the engagement.

14. Relationship of Parties. The relationship of the Consultant to the Commission hereunder is that of an independent contractor, and the Consultant, except to the extent expressly

provided to the contrary on Schedule A hereto, shall have no right or authority to make contracts or commitments for or on behalf of the Commission, to sign or endorse on behalf of the Commission any instruments of any nature or to enter into any obligation binding upon the Commission. This Agreement shall not be construed as an Agreement of partnership, joint venture, or agency.

15. Miscellaneous.

a. **Consultant's Authority.** Execution of this Agreement by the Consultant is authorized by a resolution of its Board of Directors, if a corporation, or similar governing document if a partnership or a joint venture, and the signatures(s) of each person signing on behalf of the Consultant have been made with complete and full authority to commit the Consultant to all terms and conditions of this Agreement, including each and every representation, certification and warranty contained or incorporated by reference in it.

b. **Counterparts.** This Agreement may be executed in any number of counterparts, any of which shall be deemed an original.

c. **Entire Agreement.** This Agreement constitutes the entire understanding and Agreement between the parties hereto and supersedes any and all prior or contemporaneous oral or written representations or communications with respect to the subject matter hereof, all of which communications are merged herein. This Agreement shall not be modified, amended or in any way altered except by an instrument in writing signed by both of the parties hereto.

d. **Force Majeure.** Neither of the parties shall be liable to the other for any delay or failure in performance hereunder due to causes which are beyond the control of the party unable to perform. If a force majeure occurs, the party delayed or unable to perform shall give prompt notice to the other party, and the Commission may, at any time during the continuation of the force majeure event, elect to suspend the performance of the Consultant under this Agreement for the duration of the force majeure. The Commission shall not be obligated to pay for Services to the extent and for the duration that performance thereof is delayed or prevented by force majeure, but, provided the Consultant is not in default of any obligation of the Consultant hereunder, the Commission shall pay to the Consultant, according to the terms hereof, all compensation and reimbursements due to the Consultant for periods up to the effective date of suspension.

e. **Governing Law.** This Agreement has been negotiated and executed in the State of Illinois and shall be construed under and in accordance with the internal laws of the State of Illinois.

f. **No Waiver.** The waiver by either party of any breach of this Agreement shall not constitute a waiver as to any succeeding breach.

g. **Notices.** All notices required to be given hereunder shall be given in writing and shall be hand delivered or sent by United States certified or registered mail, postage prepaid, addressed to Commission and to the Consultant at their respective addresses set forth above. If given as herein provided, such notice shall be deemed to have been given on the date of delivery, if delivered by hand, and on the second business day after mailing, if given by mail. The Commission

or the Consultant may, from time to time, change the address to which notices hereunder shall be sent by giving notice to the other party in the manner provided in this subparagraph.

h. **Reimbursable Expenses** as herein referred to includes actual expenditures, as identified in Schedule C, made by the Consultant.

i. **Severability.** In the event that any provisions of this Agreement shall be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

j. **Successors and Assigns.** Except as otherwise provided herein, this Agreement shall be binding upon and inure to the benefit of each of the parties hereto and their respective successors and assigns.

k. **Intermediaries.** The Consultant may elect to utilize the services of other intermediaries to assist in the marketing of the Commission's insurance (including brokers in the London and other markets), when in Consultant's professional judgment those services are necessary or appropriate. Such intermediaries may be affiliates of Consultant or not related to Consultant. The compensation of such intermediaries is not included in Consultant's compensation under this Agreement and will be paid by insurers out of paid premiums. Consultant will advise the Commission in writing of utilization of intermediaries prior to placement of coverage.

l. **Notification of Excess Carriers.** Effective upon the renewal or placement by Consultant of the Commission's excess insurance program, unless the Commission gives the Consultant Client Executive contrary instructions in writing, whenever the Consultant Client Executive is informed in writing by the Commission that a claim has been notified to the primary carrier, Consultant will notify all applicable excess carriers where Consultant has placed the applicable excess policies or the Consultant Client Executive has been provided written notice by the Commission of the applicable carrier and policies. If Consultant is instructed not to provide notice to any excess carrier, Consultant shall have no responsibility for any consequences arising out of the failure to give notice.

m. **Existing Policies.** If Consultant has taken over any existing program or policies implemented by another broker, Consultant will not assume any responsibility for the adequacy or effectiveness of those programs or policies or any actions or omissions occurring prior to Consultant's retention. Within 45 days, Consultant will have completed a review of those programs and policies and will make recommendations it believes are necessary.

n. **Relationship between Consultant and Insurers.** Consultant does not speak for any insurer, is not bound to utilize any particular insurer, and does not have the authority to make binding commitments on behalf of any insurer.



Willis of Illinois, Inc. will perform the following services for the Client related to the placement of property and casualty insurance coverages specified in the RFP, included by reference.

Services will include, but are not limited to:

- a. Design, market and implement coverage as identified in Attachment A of the RFP, at the most reasonable cost and broadest terms.
- b. In collaboration with the Commission's Risk Manager (or as directed by the Commission), develop a plan to establish activities, deliverables, and other matters pertinent to the requested services.
- c. Identify those markets that are able to provide the insurance and services desired. Markets are to be financially stable.
- d. Develop the specification package and application for coverage outlined in Attachment A of the RFP, presenting the risk exposure and other information in a form acceptable to underwriters.
- e. Present insurance specifications to the marketplace, respond to underwriters' questions and provide additional information, if requested.
- f. Receive and analyze underwriters' quotations. Determine whether they adhere to the specifications and that the premium quoted is fair and reasonable within the marketplace. Negotiate any changes and refinements on terms.
- g. Submit insurance proposal to Commission's Risk Manager (or as directed by the Commission) at least 21 business days prior to expiration, providing a cost analysis by line of coverage, a matrix comparison of PBC's insurance specifications with the insurance policies quoted, and a recommendation. Analysis must include copies of all policy forms and endorsements to be included in the issued policies.

At least 120 days prior to renewal, Consultant will provide Client with a renewal action plan timeline including accountability and also establish objective of Client for the forthcoming renewal. The report will include the following:

- List of all insurance policies in force by policy number(s), comprehensive descriptions of insurance coverage(s) in effect, limits, deductibles, inception/expiration dates, insurance carriers, and premiums including all surplus lines, taxes and fees.
  - An overall evaluation of the insurance program;
  - Recommendations regarding proper arrangements for lines of coverage, improvements, adequacy of coverage in effect and best method to reduce insurance costs;
  - Suggested insured exposures that may be absorbed or reduced within the guidelines established by the Client
- h. Place coverage upon Commission's approval.
- i. Five business days prior to expiration, submit insurance binders to the Commission's Risk Manager (or as directed by the Commission) that have been checked for coverage's terms, conditions, limits, deductibles, premiums, and carrier participation of each binder.
- j. Provide an insurance summary of each line of insurance coverage, including but not limited to, effective dates, policy limits, insuring agreements, exclusions, annual premium (including surplus lines tax and other fees) and exposure basis. Provide coverage summaries for all new coverages and updates on changes to existing coverages.
- k. Submit original policies and endorsements, including surplus lines and stamping fees (if applicable), to the Commission within 60 days of effective dates. Written report must be submitted for each policy bound outlining any errors, discrepancies or other inconsistencies from the final proposal and/or binders. All policy changes and/or corrections must be processed within 30 days.
- l. Receive, review, coordinate, process and monitor all claims, transmit all support documents to insurers, and assist in settlement and/or payment and closing of all claims.
- m. Establish claim-reporting procedures including contact personnel names and phone numbers. Identify a claim coordinator and provide appropriate forms and instructions for use. (Such forms must have mailing address of primary recipients printed on them).
- n. Place additional related insurance coverage when necessary.
- o. Perform safety and loss control inspections when necessary.
- p. Issue required certificates of insurance when necessary.
- q. Review, validate and approve all premium invoices and billings regarding insurance policies and endorsements.

- r. Provide immediate notice to the Commission of any change in key personnel during the term of the contract. Replacement personnel must be identified and have the same qualifications as the key personnel departing.
- s. Supply the Commission's Risk Manager (or as directed by the Commission) with a written letter each month that clearly identifies all open/pending items for each line of coverage. Advise Risk Manager of significant trends in the insurance marketplace.
- t. Prepare and submit written reports to Commission's Risk Manager (or as directed by the Commission), as requested.
- u. Be available to answer questions and provide assistance to the Commission seven days per week, twenty-four hours a day. Pager and Mobile phone numbers of key personnel are to be provided by the Consultant to the Commission.

## Schedule C

### Compensation of the Consultant

#### C.1 Compensation

C.1.1 The Consultant will be compensated on an annual fixed fee of Fifty-Seven Thousand Dollars (\$57,000.00). The Commission's objective is to identify and fully disclose the total cost of servicing the insurance program through the establishment of an overall fixed flat-fee arrangement. As a means of verification, the Commission may, at its sole discretion, request affidavits from participating insurers certifying that no commissions of any type has been paid to the Consultant, by any insurer. There may be circumstances where insurance companies will not reduce the premium when eliminating commission. In these situations, the Commission may allow the Consultant to receive such commissions. However, the Consultant must fully disclose any and all such commissions received and reduce the flat-fee by the corresponding dollar amount. As a means of verification, the Commission may, at its sole discretion, request affidavits from the insurer(s) certifying the amount and type of commissions paid to the Consultant. Fees will be paid 50% when liability coverage is bound and 50% when property coverage is bound.

C.1.1.1 Unless otherwise provided herein, the Consultant, its affiliates and subsidiaries shall not receive any fee, credit, rebate or item of value from an insurer, or any other party related to an insurer, as payment for either receiving or being considered for PBC insurance.

#### C.2 Changes to Scope

C.2.1 The Commission may compensate the Consultant for additional services that are not incorporated into the Scope of this agreement on a lump sum basis. Fees for such additional services shall be agreed upon by the Consultant and the commission prior to the incorporation of the additional scope to this agreement.

#### C.3 Submission of Invoices

C.3.1 The Consultant shall submit invoices in accordance with paragraph 5.b of this agreement for the services to be provided. Invoices are to be submitted 30 days prior to payment due date.

## Schedule D

### INSURANCE REQUIREMENTS

The Consultant must provide and maintain at Consultant's own expense, during the term of the Agreement and time period following expiration if Consultant is required to return and perform any of the Services or Additional Services under this Agreement, the insurance coverage and requirements specified below, insuring all operations related to the Agreement.

#### A. Insurance to Be Provided

##### 1) Workers Compensation and Employers Liability

Workers Compensation Insurance, as prescribed by applicable law, covering all employees who are to provide a service under this Agreement and Employers Liability coverage with limits of not less than \$100,000 each accident or illness.

##### 2) Commercial General Liability (Primary and Umbrella)

Commercial General Liability Insurance or equivalent with limits of not less than \$2,000,000 per occurrence for bodily injury, personal injury and property damage liability. Coverage must include the following: All premises and operations, products/completed operations, separation of insureds, defense and contractual liability (with no limitation endorsement). The Public Building Commission is to be named as an additional insured on a primary, non-contributory basis for any liability arising directly or indirectly from the Services.

##### 3) Automobile Liability (Primary and Umbrella)

When any motor vehicles (owned, non-owned and hired) are used in connection with Services to be performed, Consultant must provide Automobile Liability Insurance with limits of not less than \$1,000,000 per occurrence for bodily injury and property damage. The Public Building Commission is to be named as an additional insured on a primary, non-contributory basis.

##### 4) Professional Liability/Errors and Omissions

When any professional consultants perform Services in connection with this Agreement, Professional Liability/Error and Omissions Insurance covering acts, errors or omissions must be maintained with limits of not less than \$2,000,000. Coverage must include contractual liability. When policies are renewed or replaced, the policy retroactive date must coincide with, or precede, start of Services on the Agreement. A claims-made policy, which is not renewed or replaced, must have an extended reporting period of 2 years.

#### B. Additional Requirements

Consultant must furnish the Public Building Commission, Richard J. Daley Center, 50 West Washington Street, Room 200, Chicago, IL 60602, original Certificates of Insurance, or such similar evidence, to be in force on the date of this Agreement, and

Renewal Certificates of Insurance, or such similar evidence, if the coverages have an expiration or renewal date occurring during the term of this Agreement. Consultant must submit evidence of insurance prior to Agreement award. The receipt of any certificate does not constitute agreement by the Commission that the insurance requirements in the Agreement have been fully met or that the insurance policies indicated on the certificate are in compliance with all Agreement requirements. The failure of the Commission to obtain certificates or other insurance evidence from Consultant is not a waiver by the Commission of any requirements for the Consultant to obtain and maintain the specified coverages. Consultant must advise all insurers of the Agreement provisions regarding insurance. Non-conforming insurance does not relieve Consultant of the obligation to provide insurance as specified in this Agreement. Non-fulfillment of the insurance conditions may constitute a violation of the Agreement, and the Commission retains the right to suspend this Agreement until proper evidence of insurance is provided, or the Agreement may be terminated.

The insurance must provide for 60 days prior written notice to be given to the Commission in the event coverage is substantially changed, canceled or non-renewed.

Any deductibles or self-insured retentions on referenced insurance coverages must be borne by Consultant.

Consultant agrees that insurers waive their rights of subrogation against the Public Building Commission, its employees, elected and appointed officials, agents or representatives.

The coverages and limits furnished by Consultant in no way limit the Consultant's liabilities and responsibilities specified within the Agreement or by law.

Any insurance or self-insurance programs maintained by the Public Building Commission do not contribute with insurance provided by Consultant under this Agreement.

The required insurance to be carried is not limited by any limitations expressed in the indemnification language in this Agreement or any limitation placed on the indemnity in this Agreement given as a matter of law.

Consultant must require all Subconsultants to provide the insurance required in this Agreement, or Consultant may provide the coverages for Subconsultants. All Subconsultants are subject to the same insurance requirements of Consultant unless otherwise specified in this Agreement.

If Consultant or Subconsultants desires additional coverage, the party desiring the additional coverage is responsible for the acquisition and cost.

The Public Building Commission maintains the right to modify, delete, alter or change these requirements.

### Notes 1-5 Disclosure Affidavit

1. Business entities are affiliated if, directly or indirectly, one controls or has the power to control the other, or if a third person controls or has the power to control both entities. 
