THIS FOURTH AMENDMENT AGREEMENT is made and entered into as of the 1st day of February, 2008, and is part of the contract for Architect of Record Services ("Agreement") between by and between the PUBLIC BUILDING COMMISSION OF CHICAGO, a municipal corporation of the State of Illinois ("Commission") and Bauer Latoza Studio Ltd, ("Architect") dated March 8, 2005 with the like operation and effect as if the same were incorporated therein.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

2. Schedule A

Scope of Services A. 6 – Additional Responsibilities and Representations is revised to add the following services:

A.6.5 Architect is to complete the necessary engineering work and modifications of as-bid plans and specifications to meet the requirements of the Global Building Maintenance System.

3. Schedule C - Compensation of the Architect

Section C.1 Architect Fee is revised to add the following:

C.1.3 The Architect shall be paid the amount of \$5040.00 for the additional services outlines in Item 2 of this Amendment 3. The Fixed Fee is increased to \$268,353.00.

Execution of this Amendment by the Architect is duly authorized by the Architect, and the signature(s) of each person signing on behalf of the Architect have been made with the complete and full authority to commit the Architect to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.
