

**PUBLIC BUILDING COMMISSION OF CHICAGO
SECOND AMENDMENT
CONTRACT NUMBER PS 1099**

THIS SECOND AMENDMENT AGREEMENT is made and entered into as of the 16th day of December, 2010, and shall be deemed and taken as forming a part of the Agreement for Architect of Record Services ("Agreement") between by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **STUDIO GANG ARCHITECTS, LTD.**, ("Architect") dated May 8, 2007 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Architect have heretofore entered into an Agreement dated the 8th day of May, 2007, wherein the Architect is to provide Architect of Record Services for Ford Calumet Environmental Center and;

WHEREAS, the Commission and Architect now desire to amend the Agreement to include Additional Services performed and associated compensation due to Architect;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. Schedule A - Scope of Services is amended to include the following Additional Services required for Ford Calumet Environmental Center to perform Architect of Record services:

- 2.1 Provide support, including presentations and graphical information, for marketing purposes required to support the Financial Advisors' efforts to secure project financing.

3. Schedule D Compensation of the Architect

3.1 Section 1.A. Architect's Fee is revised to include as follows:

The Architect shall be paid the amount of \$30,000.00 for the Additional Services outlined in Item 2 of this Amendment 2.

3.2 Section IV.C. Reimbursable Expenses is revised to include as follows:

The Architect's Reimbursable Expenses shall be increased by \$1,500.00 to cover reproduction and copying services required to complete the Additional Services outlined in Item 2 of this Amendment 2.

Execution of this Amendment by the Architect is duly authorized by the Architect, and the signature(s) of each person signing on behalf of the Architect have been made with the complete and full authority to commit the Architect to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.
