

**FIRST AMENDMENT  
PUBLIC BUILDING COMMISSION OF CHICAGO  
MASTER LANDSCAPE ARCHITECTURE SERVICES  
CONTRACT NUMBER PS 1134**

**THIS FIRST AMENDMENT AGREEMENT** is made and entered into as of the 4<sup>th</sup> day of June, 2010, and shall be deemed and taken as forming a part of the Agreement for Master Landscape Architecture Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **DLK ARCHITECTURE, INC. dba DLK CIVIC DESIGN** ("Consultant") dated July 1, 2007 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Consultant have heretofore entered into an Agreement dated the 1st day of July, 2007, ("Agreement"), wherein the Consultant is to provide Master Landscape Architecture Services for the Commission; and

**WHEREAS**, the Commission and Consultant now desire to amend the Agreement to include additional Services performed and associated compensation due to Consultant;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

**TERMS**

1. **Recitals**  
**THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.**
2. **Schedule A Scope of Services.** Consultant will complete design architect services on various projects on a Task Order basis as needed.
3. **Article V, Section 5.01** is revised to extend the term of Agreement to November 30, 2010.

Execution of this Amendment by Consultant is duly authorized by Consultant, and the signature(s) of such person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended or modified herein, all terms of the Agreement shall remain in force and effect.

The terms of the Agreement remain in full force and effect except as modified in this Amendment.
