

**PUBLIC BUILDING COMMISSION OF CHICAGO  
FIRST AMENDMENT  
CONTRACT NUMBER PS1367**

**THIS FIRST AMENDMENT AGREEMENT** is made and entered into as of the 8th day of October, 2009, and shall be deemed and taken as forming a part of the Agreement for Construction Material Testing Services ("Agreement") for Kelly Curie Gage Park High School between by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **GSG MATERIAL TESTING, INC.** ("Consultant") dated August 19, 2008 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Consultant have heretofore entered into an Agreement dated the 19<sup>th</sup> day of August, 2008, ("Agreement"), wherein the Consultant is to provide Construction Material Testing Services for Kelly Curie Gage Park High School; and

**WHEREAS**, the Commission and Consultant now desire to amend the Agreement to include additional Services performed and associated compensation due to Consultant;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

**TERMS**

1. **Recitals**  
**THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.**
  
2. **Schedule A – Scope of Services** is revised to add the following services:
  1. Provide an engineer technician to visually inspect the placement of all concrete including footing, foundation walls, curb and gutter and drive way, and other areas, and perform slump, air entrainment, and temperature test on concrete prior to placement. The field technician will also prepare concrete cylinders for compressive strength test. The number of cylinders and laboratory test will be performed in accordance with the project specifications, if required.

2. Provide an engineer technician to perform field density during the placement of parking lot sub-base and asphalt pavement. The field technician will perform field density using a nuclear gauge and we will also collect asphalt samples for laboratory testing, if required.

3. Perform random testing during the placement of masonry walls. The field technician will inspect reinforcement and collect grout, mortar, and prism samples for laboratory testing made by the contractor. For the purpose of this proposal we assumed that 1 test will be performed for every 5,000 ft<sup>2</sup>, if required.

4. Provide all required laboratory testing.

5. Perform additional inspection services as requested by the owner.

6. Prepare and submit written reports on all inspections and testing. Reports will summarize all findings, conclusion and recommendations determined during testing procedures. All field reports will be prepared under the supervision of a Professional Engineer registered in the State of Illinois. Field reports will be typed and emailed to on a weekly basis.

### **3. Schedule C Compensation of the Consultant**

**Section C.1. Consultant's Fee** is revised to include as follows:

The Consultant shall be paid the not-to-exceed amount of \$86,805.00 for the additional services outlined in Item 2 of this Amendment 1.

The Not to Exceed Fee is increased to a total of \$271,805.00

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.

IN WITNESS WHEREOF, the parties hereto have agreed and executed this Amendment Agreement No. 1.

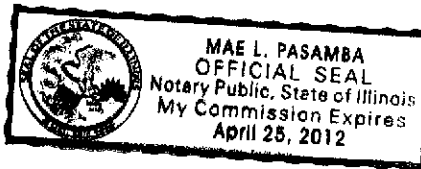
