

**THIRD AMENDMENT

THIS THIRD AMENDMENT AGREEMENT is made and entered into as of the 13th day of April, 2011, and shall be deemed and taken as forming a part of the Agreement for ALTA Survey Services for Edgewater Replacement Library ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **ALFRED BENESCH & COMPANY** ("Consultant") dated September 25, 2008 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement dated September 25, 2008, wherein the Consultant is to provide ALTA Survey Services for the City of Chicago; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to include additional Services performed and associated compensation due to Consultant;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. Schedule A Scope of Services is amended to include additional services required for Edgewater Replacement Library to perform ALTA Survey services. The scope for this Service is detailed in Attachment A to this Amendment 1.

3. Schedule C Compensation of the Consultant is revised as follows:

C.1 The Consultant shall be paid the Lump Sum amount of \$3,000.00 for the additional Services.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.


The terms of the Agreement remain in full force and effect as modified in this Amendment.





SCOPE OF WORK
THIRD AMENDMENT
ALTA SURVEY SERVICES
EDGEWATER BRANCH LIBRARY
CONTRACT NUMBER PS 1408
PROJECT NO.: 08050

The scope of services includes, but is not limited to the following:

- Update an existing survey already in Basic format;
- In the public alley provide spot elevations along the east and west property lines at 30 foot intervals;
- Survey and locate all entrances to properties along the public alley, this includes garage aprons and their conditions;
- Provide all utility information in the alley including locations of aerial utility lines;
- Provide invert elevations of sewer manholes No 7, 11 and 12 in Broadway;
- Provide curb elevations at 30 foot intervals along Broadway. (Currently these elevations are more than 100 feet apart.);
- Provide condition of sewer manhole at the intersection of the east-west public alley;
- Provide topographic information 30 feet west of the public alley, to include the intersections with West Elmdale, West Norwood Avenue and the east-west public alley;
- Provide details of the signage on sign poles in the public right of way on the west side of Broadway and north side of West Elmdale Avenue; and
- Provide cost for two (2) survey updates for the purpose of obtaining a building permit.
