

**PUBLIC BUILDING COMMISSION OF CHICAGO
FIRST AMENDMENT
CONTRACT NUMBER PS1169**

THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 14th day of September, 2010, and is part of the contract for Architect of Record Services ("Agreement") between by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **DLR Group** ("Architect") dated August 12, 2008 with the like operation and effect as if the same were incorporated therein.

WITNESS:

WHEREAS, the Commission and Architect have previously entered into an Contract dated the 12th day of August, 2008, ("Agreement"), wherein the Architect is to provide Architect of Record services; and

WHEREAS, the Commission and Architect now desire to amend the Agreement to include additional services to the Scope of Services;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and this amendment, the parties mutually agree to amend the Agreement as here after stated.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. **Recitals**
THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. **Schedule A**

Scope of Services IV. – Additional Services is revised to add the following services:

- D. The Architect will provide the following additional services; redesign for the addition of an ice maker and associated plumbing and electrical connections
- E. The addition of infrastructure for a future cabinet unit heater in the hose tower and associated mechanical and electrical connections.

3. Schedule D - Compensation of the Architect

Section D.1 Architect Fee is revised to add the following:

C.1.6 The Architect shall be paid the amount of \$2,700.00 for the additional services outlined in Item 2 of this Amendment 1. The Fixed Fee is increased to \$911,960.00.



All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.



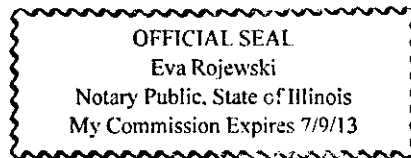
