THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 9th day of November, 2011, and shall be deemed and taken as forming a part of the Agreement for Manufacture and Installation of Construction Signage Services ("Agreement") by and between the PUBLIC BUILDING COMMISSION OF CHICAGO, a municipal corporation of the State of Illinois ("Commission") and The Blue Print Shoppe ("Vendor") dated January 16, 2009 with the like operation and effect as if the same were incorporated therein.

- Compensation of the Vendor is revised as follows: Schedule B
 - The Vendor shall be paid a not to exceed amount of \$12,000.00 per year for the satisfactory performance of Services. Vendor will be compensated for Services provided as indicated in Attachment B of this Amendment 1.

Execution of this Amendment by the Vendor is duly authorized by the Vendor, and the signature(s) of each person signing on behalf of the Vendor have been made with the complete and full authority to commit the Vendor to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.
