### PUBLIC BUILDING COMMISSION OF CHICAGO THIRD AMENDMENT CONTRACT NUMBER C1488

THIS THIRD AMENDMENT AGREEMENT is made and entered into as of the 11th day of January, 2011, and shall be deemed and taken as forming a part of the Agreement for Unarmed Security Guard Services ("Agreement") for the Michael Reese Hospital Campus between by and between the PUBLIC BUILDING COMMISSION OF CHICAGO, a municipal corporation of the State of Illinois ("Commission") and SKYTECH ENTERPRISES, LTD.   - THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.
- Section 3 Bid and Execution Documents
  - Section 3.2 Estimated Quantity is revised to add the following quantities:

On Line Item #2 for the description of Supervisor, add 9,432 hours to provide additional security services from January 31, 2011 through December 31, 2011 at an hourly rate of \$16.22.

One Line Item #3 for the description of Monthly Vehicle Rental Rate Extended Cost add \$8,820.00, increasing the car allowance for the security guard's use.
