 - THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT CONTRACT AS THOUGH FULLY SET FORTH HEREIN.
- 2. Book 1 Contract Performance Period is revised to extend the term of the Contract to March 10, 2012.

Execution of this Amendment by the Contractor is duly authorized by the Contractor, and the signature(s) of each person signing on behalf of the Contractor have been made with the complete and full authority to commit the Contractor to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Contract. Except as and to the extent that the terms of the Contract are amended and modified herein, all terms of the Contract shall remain in force and effect.

The terms of the Contract remain in full force and effect except as modified in this Amendment.
