## PUBLIC BUILDING COMMISSION OF CHICAGO SECOND AMENDMENT CONTRACT NUMBER PS 1644

THIS SECOND AMENDMENT AGREEMENT is made and entered into as of the 1st day of October, 2010, and shall be deemed and taken as forming a part of the Agreement for Architect of Record Services for Back of the Yards High School ("Agreement by and between the PUBLIC BUILDING COMMISSION OF CHICAGO, a municipal corporation of the State of Illinois ("Commission") and STL ARCHITECTS ("Consultant") dated July 14, 2009 with the like operation and effect as if the same were incorporated therein.

## WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement dated the 14th day of July, 2009, wherein the Consultant is to provide Architect of Record Services for the City of Chicago; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to include additional Services performed and associated compensation due to Consultant;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

## TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

- Schedule A Scope of Services is amended to include the following additional services required for Back of the Yards High School to perform Architect of Record services.
  - 2.1 Design Change to the Back of the Yards High School Consultant will modify the design to incorporate the following:
    - 2.1.1 Freight elevator: in ground, holed, hydraulic, C3, 4000 lbs., service.
    - 2.1.2 Passenger elevator: Class A, 4500 lbs. MRL, service. Consultant to produce specification.
  - 2.2 Site Development Changes to the Back of the Yards High School Consultant is to perform all necessary design work to update the site development at the intersection of 47th and Hoyne, pursuant to Plan Commission recommendations.
- 3. Schedule D Compensation of Architect

Section I. Architect's Fee is revised as follows:

- 3.1 The Commission shall pay the Consultant for the satisfactory performance of the additional services outlined in Item 2.1 above for a time card not-to-exceed amount of \$19,000.00
- 3.2 The Commission shall pay the Consultant for the satisfactory performance of the additional services outlined in Item 2.2 above for a time card not-to-exceed amount of \$37,268.00

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.

The terms of the Agreement remain in full force and full force and effect as modified in this Amendment.
