NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

Recitals 1.

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

- Schedule A Scope of Services is amended to include that the Consultant shall perform the following Additional 2. Services required for Back of the Yards High School.
 - 2.1 Consultant will provide additional design and engineering services associated with program changes related to the Chicago Public Schools/Chicago Public Library shared-use community library.
- Schedule D Compensation of Architect 3.

Section I. Architect's Fee is revised as follows:

The Commission shall pay the Consultant a lump sum fee of \$100,000.00 for the satisfactory performance of 3.1 the Additional Services outlined in Item 2.1.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.
