

**PUBLIC BUILDING COMMISSION OF CHICAGO
PROFESSIONAL SERVICES AGREEMENT - FIRST AMENDMENT
2009 ANNUAL REPORT CONSULTING SERVICES - PS1814**

THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 9th day of November, 2010, and shall be deemed and taken as forming a part of the Agreement for the 2009 Annual Report Consulting Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **A. LVELLE CONSULTING SERVICES, LLC.** ("Consultant") dated April 6, 2010 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement dated the 6th day of April, 2010, wherein the Consultant is to provide 2009 Annual Report for the Commission; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to include additional Services performed and associated compensation due to Consultant;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. Exhibit A Description of Services is amended to include additional services required for 2009 Annual Report. The scope for this service is detailed as follows:

2.1 The Consultant shall provide additional editing, proofing and text revisions due to changes in the design of the 2009 Annual Report.

3. Exhibit B Compensation of the Consultant is revised as follows:

B.1.1 The Consultant shall be paid the not to exceed amount of \$8,000.00 for the additional services outlined in Item 2.1 of this Amendment 1.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.

The terms of the Agreement remain in full force and full force and effect as modified in this Amendment.

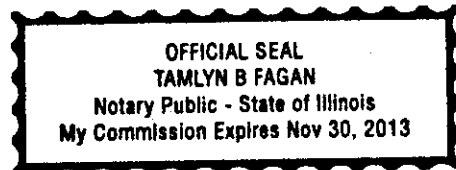
