

**SIXTH AMENDMENT  
ARCHITECT OF RECORD SERVICES  
EDGEWATER LIBRARY  
CONTRACT NUMBER PS1862**

**THIS SIXTH AMENDMENT AGREEMENT** is made and entered into as of the 11<sup>th</sup> day of September, 2012, and shall be deemed and taken as forming a part of the Agreement for Architect of Record Services at Edgewater Library ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **LOHAN ANDERSON, LLC**. ("Architect") dated November 9, 2010 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Architect have heretofore entered into an Agreement dated the 9<sup>th</sup> day of November, 2010, wherein the Architect is to provide Architect of Record services for the City of Chicago; and

**WHEREAS**, the Commission and Architect now desire to amend the Agreement to include Additional Services performed and associated compensation due to Architect;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

**TERMS**

1. **Recitals**  
**THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.**
2. **Schedule A Scope of Services** is amended to include the following Additional Services required for Edgewater Library:
  - 2.1 Architect will provide additional design services associated with the modification of the mechanical room layout.
  - 2.2 Architect will provide additional design services associated with the addition of lounge furniture to the 1<sup>st</sup> and 2<sup>nd</sup> floors.
3. **Schedule D Compensation of the Architect**
  - 3.1 The Commission shall pay the Architect a lump sum fee of \$7,405.00 for the satisfactory performance of the Additional Services outlined in Item 2.1 above.
  - 3.2 The Commission shall pay the Architect a lump sum fee of \$4,545.00 for the satisfactory performance of the Additional Services outlined in Item 2.2 above.
  - 3.3 The Commission shall pay the Architect a total lump sum fee of \$11,950.00 for the satisfactory performance of all of the Additional Services outlined in this Sixth Amendment.

Execution of this Amendment by the Architect is duly authorized by the Architect, and the signature(s) of each person signing on behalf of the Architect have been made with the complete and full authority to commit the Architect to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.

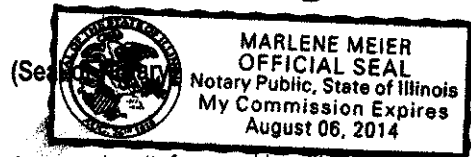
