THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 18th day of July, 2011, and shall be deemed and taken as forming a part of the Agreement for Review of Earth Retention System Design at Williams Jones College Prep ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **AECOM** ("Consultant") dated December 21, 2010 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement dated December 21, 2010, wherein the Consultant is to provide Review of Earth Retention System Design at William Jones College Prep; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to include additional Services performed and associated compensation due to Consultant;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. **Recitals**

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. **Schedule A Scope of Services** is amended to include that the Consultant shall perform additional Services at Williams Jones College Prep. The Scope of additional Services for this Amendment 1 are detailed in Attachment A.

3. **Schedule C Compensation of the Consultant** is revised as follows:

C.1 The Consultant shall be paid the Not to Exceed amount of **\$10,000.00** for the additional Services.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.



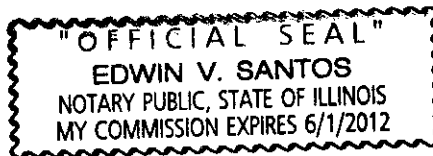

SCOPE OF WORK REVIEW OF EARTH RETENTION SYSTEM DESIGN WILLIAM JONES COLLEGE PREP PROJECT NO.: 05265 CONTRACT NUMBER PS1881

The Scope of Services includes but is not limited to the following:

- Caisson squeeze monitoring services above and beyond the Independent Testing Laboratory testing services from GSG Material Testing as a condition of foundation permit approval;
- Consultant will have engineer on site to review select Caisson installations as required by permit to ensure that squeeze of the soft clay is not taking place as well as verify that the approved Caisson procedures are being followed.
