

**FIRST AMENDMENT  
COMPREHENSIVE DIGITAL CONSTRUCTION PRINTING SERVICES

**THIS FIRST AMENDMENT AGREEMENT** is made and entered into as of the 9th day of August, 2011, and shall be deemed and taken as forming a part of the Agreement for Comprehensive Digital Construction Printing Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **Springer Blue Print Service** ("Vendor") dated September 1, 2009 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Vendor have heretofore entered into an Agreement dated September 1, 2009, wherein the Vendor is to provide Comprehensive Digital Construction Printing Services for the Commission; and

**WHEREAS**, the Commission and Vendor now desire to amend the Agreement to extend the Term of the Agreement and to include additional associated compensation due to Vendor;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in and amendments to the Agreement pursuant to this Amendment are as follows:

**TERMS**

**1. Recitals**

**THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.**

**2. 5.0.b Agreement Extension Option;**

The Commission has elected to extend this Agreement for two additional years.

**Schedule B Compensation of the Vendor** is revised as follows:

**B.1** The Vendor shall be paid for the satisfactory performance of the Services as a not to exceed amount of **\$100,000.00** for Services performed during the term of the First Amendment. Vendor will be compensated for Services provided as indicated on the attached vendor price list Attachment C of this Amendment 1.

Execution of this Amendment by the Vendor is duly authorized by the Vendor, and the signature(s) of each person signing on behalf of the Vendor have been made with the complete and full authority to commit the Vendor to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.

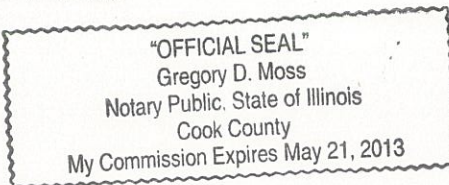
