

**FIRST AMENDMENT  
INSURANCE BROKERAGE SERVICES CATEGORY 2

**THIS FIRST AMENDMENT AGREEMENT** is made and entered into as of the 11<sup>th</sup> day of September 2018, and shall be deemed and taken as forming a part of the Agreement for Insurance Brokerage Services Category 2 ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **CS Insurance Strategies, Inc.** ("Consultant") dated October 1, 2015 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Consultant have heretofore entered into an Agreement dated the 1st day of October 2015 wherein the Consultant is to provide Insurance Brokerage Services Category 2 for Public Building Commission of Chicago; and

**WHEREAS**, the Commission and Consultant now desire to amend the Agreement to extend the term of the Agreement;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in and amendments to the Agreement pursuant to this Amendment are as follows:

**TERMS**

1. **Recitals**  
**THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.**
2. **Term**
  - 2.1 This amendment is an extension of the existing Insurance Brokerage Services Category 2 contract through October 1, 2019.
3. **Compensation of the Consultant**
  - 3.1 The Compensation to be paid to the Consultant under this Amendment is \$6,000.00.

Execution of this Amendment by the Consultant is duly authorized by the Consultant and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.

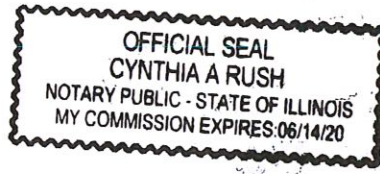
