RFI-1.

Question: Reference sheet A7.08 elevation 3 and 6. In elevation 3 it doesn't clarify the size of the projection

screen as well doesn't say anything on the equipment list about projection screens.In elevation 6 projection screen in words are floating there, is it one here or not. Please clarify the sizes and if it

should be an additional one in elevation 6.

Response: There is only one projection screen as indicated on elevation detail 3/A7.08. Its dimensions are

120" Diagonal 4:3 format; 92"w x 69" h; Ceiling recessed. Disregard Elevation Detail 6/A7.08 that

includes the floating word "Project Screen."

RFI-2.

Question: I have a question regarding the tackboards and the projection screen. What are the dimensions

of the tackboards above the lockers (A7.09, A7.10)? Also, on the ceiling plan (A2.01) there is only one projection screen in the multipurpose room however, in the elevation drawings (A7.08) on details 3 and 6, there are 2 projection screens listed. Please let me know the dimensions of the

tackboards and how many projection screens are in the building.

Response: Refer to Answer 2. There is only one projection screen per elevation detail 3/A7.08. The Tack

Boards above lockers are 1/4"cork material laminated to wall, approximately 2' 4"h. Refer to

A7.09 & A7.10 and spec. section 09 72 13.

RFI-3.

Question: The specifications call for aluminum windows yet the sites lines shown on A8.02 imply storefront

with vents with the 2 1/2" site-line between the windows at Window Types A, C, D & G. Please confirm that they are in fact windows with mullions which would make the sidelines slightly

wider between the windows.

Response: All Window Types shall be windows, not storefront. Provide wider vertical sidelines between

windows as indicated in detail 2/A8.02 on Window Types A, C, D & G per manufacturer's

standard details as indicated in specification section 08 51 13.

RFI-4.

Question: Is the aluminum windows clear anodized or dark bronze anodized?

Response: Windows shall be dark bronze anodized as noted on drawing 2/A8.02. Aluminum Entrances shall

be clear anodized as noted on drawing 3/8.02. Refer to specification section 08 51 13.

RFI-5.

Question: Sheet A1.05 "Roof Plan" on column line E.6 & 3.6 there is a note that refers to the Chiller Support

and says "see 3/A6.03 for similar flashing... Please note that detail 3/A6.03 does not relate to this

particular area on the roof. Please advise.

Response: The note indicated should read "3/A6.08" in lieu of "3/A6.03."

RFI-6.

Question: Sheet A1.05 "Roof Plan" between column line A.1 & 0.6 there is a detail 2/A6.05. This detail is

missing from sheet A6.05. Please provide this detail as it relates to this area.

Response: The detail reference should read "6/A6.05" in lieu of "2/A6.05."

RFI-7.

Question: There is a spec for metal column covers, but the note 5.01 on Architectural Floor plans are

calling out a prefab, fireproofed column and cover. What should we provide? The Architectural Floor Plans call out prefab, fireproofed columns (Firetrol) in the corridors on floors 1-4. The Structural Drawings do not show these as Firetrol columns. Are these to get the prefab, fireproofed columns per Note 5.01 or are they to be Metal Column Covers per the spec?

Please advise.

Response: Fire proof columns are required. Fire-Trol fire rated column is specified in Structural Steel

Framing 05 12 00 2.1G. A pre-finished aluminum cover (Metal Column Cover) is required also and

specified per section 07 42 15.
