## THIRD AMENDMENT CONSTRUCTION SIGNAGE SERVICES PUBLIC BUILDING COMMISSION CONTRACT NUMBER PS1984C

THIS THIRD AMENDMENT AGREEMENT is made and entered into as of the 13th day of March 2018, and shall be deemed and taken as forming a part of the Agreement for Construction Signage Services ("Agreement") by and between the PUBLIC BUILDING COMMISSION OF CHICAGO, a municipal corporation of the State of Illinois ("Commission") and Adnama, Inc. d/b/a Sign-A-Rama Downtown ("Consultant") dated December 10, 2013 with the like operation and effect as if the same were incorporated therein.

#### WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement dated the 10th day of December 2013, wherein the Consultant is to provide Construction Signage Services for the Commission; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to extend the term of the Agreement;

**NOW THEREFORE,** in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in and amendments to the Agreement pursuant to this Amendment are as follows:

#### **TERMS**

#### 1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

#### 2. Scope of Services

2.1 The Consultant is to provide Construction Signage Services as described in the attached Scope of Services, as well as any additional printing services as agreed.

### 3. Compensation of the Consultant and Term

3.1 This Amendment extends the term of the Agreement through December 31, 2019.

Execution of this Amendment by the Consultant is duly authorized by the Consultant and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.

#### **SCOPE OF SERVICES**

This document provides the minimum performance criteria for the production, delivery, and installation of construction signage.

All coordination for the delivery and installation of construction signage shall be facilitated by the Commission Representative. Any actions required by the Vendor will require PBC approval prior to work being performed.

Commission Representative: Aly Marti and PBC Project Manager

The Public Building Commission (PBC) will provide all artwork (renderings, logos, etc.) to the vendor prior to fabrication along with a **Construction Sign Order Form**.

The vendor will generate a proof of the sign and send it to the PBC for approval. Vendor must not commence fabrication of the sign prior to receiving approval from the Commission Representative or designee. The PBC will not be responsible for any productions created without proper approval.

Once approved, the vendor will fabricate the construction sign(s) to the Public Building Commissions standards:

Size: 4' x 8' x ½"

Materials: Medium density overlay wood sign

Color: 4 color

The vendor will contact the Commission Representative to schedule installation of the sign under supervision of the PBC Project Manager or designee. The sign will be installed to the specifications noted on the **Construction Sign Order Form**, i.e. fence mounted, post mounted, etc.

The vendor will be required to install the sign(s) within 14 days of receiving the order authorization, in the specified location, unless otherwise indicated by the Public Building Commission.

The PBC will provide the vendor with a map clearly marked with the sign location. It is the vendor's responsibility to JULIE (Joint Utility Locating Information for Excavators) the site prior to installation and to notify the PBC of any conflicts in sign placement.

The vendor must arrive on site on the agreed upon day for installation. Vendor must work with any other contractors that may be on site. Vendor must install the sign under the supervision of the PBC Project Manager or designee. It shall be the responsibility of the vendor to fabricate and install a sign appropriate for the area's climate.

Once the sign is installed the vendor will take a photo of the installed sign and email it to the Commission Representative as proof of installation.

Once installation is complete and photo has been received the vendor shall submit an invoice for completed work. The Commission Representative will submit the invoice for payment to the appropriate PBC Department within 10 days of receipt.

The vendor understands and agrees to the requirements and terms contained within this document.
