

**FIRST AMENDMENT

**THIS FIRST AMENDMENT AGREEMENT** is made and entered into as of the 8<sup>th</sup> day of September 2015, and shall be deemed and taken as forming a part of the Agreement for Comprehensive Construction Printing Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **The Blueprint Shoppe** ("Consultant") dated December 10, 2013 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Consultant have heretofore entered into an Agreement dated the 10<sup>th</sup> day of December 2013, wherein the Consultant is to provide Construction Signage Services for the Commission; and

**WHEREAS**, the Commission and Consultant now desire to amend the Agreement to include Additional Services performed and associated compensation due to Consultant;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.
