

**FIRST AMENDMENT
INFORMATION TECHNOLOGY SERVICES
CONTRACT NUMBER PS3004**

THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 6th day of October 2021 shall be deemed as forming a part of the Agreement for Information Technology Services (“Agreement”) by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois (“Commission”) and **Catalyst Consulting Group, Inc.** (“Consultant”) effective February 13, 2018 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Consultant entered into a Target Market IT Master Consulting Agreement – Category 1: Application Development; Category 3: Database Support; Category 6: IT Infrastructure Design and Development; Category 7: IT Management Consulting, referred to as “City of Chicago Contract # 32638”; and

WHEREAS, the City of Chicago Contract # 32638 was entered into on August 6, 2015 with an expiration date of July 31, 2021 and a maximum compensation of \$6,000,000. Currently, the contract value is \$32,258,373.80; and;

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement, known as PS3004 – the “Agreement”, effective the 13th day of February 2018, wherein the Consultant is to provide Information Technology Services to the Commission with the maximum compensation of \$250,000; and

WHEREAS, on September 2, 2021 the City of Chicago extended the City of Chicago Contract # 32638 until July 31, 2022; and

WHEREAS, the Commission and Consultant now desire to Amend Agreement PS3004 to extend the Term of the Agreement until July 31, 2022, in conformity with the City of Chicago Contract # 32638;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the City of Chicago Contract, the Agreement, and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. Term

This Agreement will expire on July 31, 2022.

Execution of this Amendment by the Consultant is duly authorized by the Consultant and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.


