

**PUBLIC BUILDING COMMISSION OF CHICAGO
FIRST AMENDMENT
DESIGN ARCHITECT FOR LANDSCAPE AND SITE DESIGN SERVICES
CONTRACT NUMBER PS1806**

THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 11th day of June, 2013, and shall be deemed and taken as forming a part of the Agreement for Design Architect for Landscape and Site Design Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **HITCHCOCK DESIGN GROUP** ("Consultant") dated August 26, 2010 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement effective as of the 26th day of August, 2010, wherein the Consultant is to provide Design Architect for Landscape and Site Design Services; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to exercise the Commission's option to extend the term of the Agreement;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. **Recitals**

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. **Article VI Terms**

Article VI. Terms, Section 6.01 Duration provides that the term of the Agreement is three (3) years with one (1) successive one-year renewal option at the sole discretion of the Commission. The Commission has approved an extension of the Agreement to September 1, 2014 and the term of this Agreement is thereby extended to September 1, 2014.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.


