The reading of the minutes of the November 7, 2018 Administrative Operations Committee meeting, which was previously distributed, was dispensed with. Upon motion duly made and seconded the minutes were unanimously adopted.

Pursuant to Section 2.06(g) of the Open Meetings Act, a public comment period was held. No comments or statements were presented by any persons.

The Chief of Staff reported on the following recommendations;

Task order awards for Environmental Engineering services to Carlson Environmental, Inc. in the amount of \$120,882.65 for the Brooks College Prep Athletic Field Improvement Project and for Environmental Reno/Demo services for \$25,272 to ATC Group Services for the Dore Elementary Pre-K Expansion Project. Awards for Material Testing services in the amount of \$23,782 to SEECO Consultants, Inc. for the Douglas Park Rehabilitation Project and to ECS Midwest for the Harrison Park Rehabilitation Project in the amount of \$12,930.

A task order award for Engineer of Record services to Milhouse Engineering and Construction, Inc., a MBE firm, in the sum of \$157,874 for the Fosco Park Rehabilitation Project.

A recommendation to approve amendments for mechanical consulting services to Element Energy Consulting, Inc. for a time extension through December 31, 2019 and to Opidis for document management and business process systems in the sum of \$150,000 through December 31, 2020.
