

**FIRST AMENDMENT
COMPREHENSIVE DIGITAL CONSTRUCTION DOCUMENT PRINTING SERVICES
PUBLIC BUILDING COMMISSION
CONTRACT NUMBER PS3001A**

THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 6th day of October 2021, and shall be deemed and taken as forming a part of the Agreement for Comprehensive Digital Construction Document Printing Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **Aloha Print Group** ("Consultant") dated October 1, 2018 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement dated the 1st day of October 2018, wherein the Consultant is to provide Comprehensive Digital Construction Document Printing Services for the Commission; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to extend the term of the agreement;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. Term

Article V TERM, Section 5.01 Duration is hereby repealed in its entirety, and replaced with the following:

Article V TERM Section 5.01 Duration: The term of this agreement begins on the Effective Date above, and, subject to the provisions in this section, continues through the Commission's final acceptance of any outstanding Project Deliverables.

Execution of this Amendment by the Consultant is duly authorized by the Consultant and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.

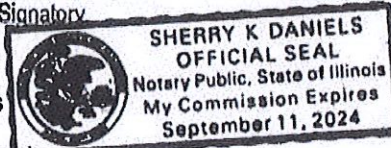
