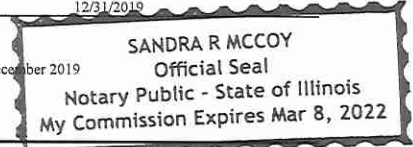

That neither the **final payment** nor any part thereof has been assigned.

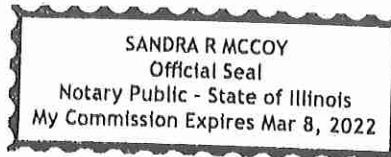
