

PUBLIC BUILDING COMMISSION MINUTES OF THE VIRTUAL ADMINISTRATIVE OPERATIONS COMMITTEE MEETING HELD MARCH 10, 2021

The reading of the minutes of the February 3, 2021 Administrative Operations Committee meeting, which was previously distributed, was dispensed with. Upon motion duly made and seconded the minutes were unanimously adopted.

Pursuant to Section 2.06(g) of the Open Meetings Act, a public comment period was held. No comments or statements were presented by any persons.

The Chief of Staff reported on the following recommendations.

A task order award for Environmental Renovation & Demolition Services in the amount of \$109,847.40 to Wood Environment & Infrastructure Solutions, Inc. for the Phillips Academy High School Athletic Amenities Annex Project. Task order awards for Surveyor Services in the amount of \$24,550 to V3 Companies of Illinois, Ltd. for the Sauganash Elementary School Annex Project and for Material Testing and Inspection Services in the amount of \$41,025 to Princeton Technical Services (MBE) for the Engine Company 115 Project.

Task order awards for Architect of Record services and one award for Engineer of Record services as follows:

- Schroeder Murchie Niemiec Gazda-Auskalnis, Ltd. in the amount of \$137,620 for the New Belmont Cragin Replacement School Project.
- Urban Works, Ltd. (MBE/WBE) in the amount of \$11,215.38 for the Rogers Elementary School Annex and Renovation Project

- 3. Tilton Kelly Bell, LLC (WBE) in the amount of \$47,250 for the Rudy Lozano Branch Library Renovation Feasibility Study Project.
- 4. Terry Guen Design Associates (MBE/WBE) in the amount of \$13,650 for the Taft Freshman Academy Connector Path Project.

The Chief of Staff reported on the process underway to appoint an Architect of Record for the Sauganash Elementary School Annex II Project. PBC held an informational session today with eighty (80) participants, including representatives from thirty-four (34) firms. We are responding to questions from the session earlier today. This project has a tight site and there are existing renovations at the school, we are looking for a firm with similar experience who can meet the deadline. Firms will submit proposals and following review of the submittals, with our partners at CPS, we will have a recommendation for the upcoming March Board Meeting.

The Chief of Staff also provided an update on PBC's work with the CDOT and AIS to enter into Intergovernmental Agreements for future projects. The intent is to present these two Intergovernmental Agreements to the March 16, 2021 Board Meeting.

The AO Committee accepted the reports from the Chief of Staff.

The Chief Development Officer provided an overview on field orders issued for various projects. He noted that all the field orders were reviewed with our clients for concurrence and approval prior to issuance. The full details are as follows:
