### PUBLIC BUILDING COMMISSION OF CHICAGO MINUTES OF THE RESCHEDULED MEETING OF THE BOARD OF COMMISSIONERS HELD ON JUNE 15, 2021 AT 2:30 P.M.

The meeting was called to order by Chairman Lightfoot, and the presence of a quorum was established.

Following the roll call, the Commissioners were advised that there were no speakers who had registered for the public participation period pursuant to Section 2.06(g) of the Open Meetings Act.

Next, Chairman Lightfoot presented to the Board for consideration of approval the minutes of the Rescheduled Board Meeting held on May 18, 2021. The reading of said minutes, which had previously been distributed, was dispensed with and upon motion duly made and seconded, the minutes of the May 18, 2021 meeting were unanimously approved.

Commissioner Maldonado then presented a report by the Administrative Operations (AO)

Committee regarding its virtual meeting held on June 9, 2021 which is summarized as follows:

The Executive Director reported on the bid opening for the Wendell Phillips Academy High School Project and will provide details during her presentation.

The Chief of Staff reported on four task orders awards, that include two Minority or Women Business Enterprise firms, for Specialty Consultant and Engineer of Record Services, to previously appointed firms.

The Chief of Staff reported on recommendations for Architect and Engineer of Record appointments for various renovation projects at libraries, fire houses, and bridges and viaduct locations. All nine of the Architecture and Engineering firms recommended are Minority or Women Business Enterprise firms.

Finally, the Chief Development Officer reported on a Change Order for Unused Commission Contingency in the credit amount of (\$203,228.93) and for liquidated damages assessed in the credit amount of (\$4,753.02) at the Mt. Greenwood Elementary School Annex Project.

The AO Committee accepted the recommendations and reports from the PBC representatives.

A copy of the Task Order Report is attached hereto as **Exhibit "A."**

The next item on the agenda was a report by Executive Director Sánchez regarding regular reports, development status and other matters. She presented to the Commissioners the Public Building Commission's "2020 Year in Review" report which summarized construction activities during the past year. The report included the 17 projects completed by the Public Building Commission during 2020, representing \$308 million in investment. During 2020, 6,367 persons earned more than \$60.5 million while working on Public Building Commission projects. The high level of participation by women and minority-owned firms was maintained during the year, with MBE participation of 29.91% or \$79,117,521 and WBE participation of 7.76% or \$20,530,251 of funds paid to date. Renovation work was completed for the following three (3) high school projects: Kenwood Academy located at 5015 S. Blackstone Avenue; Corliss High School located at 821 East 103<sup>rd</sup> Street; and Washington High School located at 35335 East 114<sup>th</sup> Street. The Dirksen Elementary School Annex project was completed at 8601 W. Foster. The Commission also completed the Engine Company 115 Project located at 1024 W. 119<sup>th</sup> Street. Library renovations were completed at the Legler Regional Library located at 115 S. Pulaski Road and the Merlo Branch Library located at 644 W. Belmont. Finally, the Executive Director advised the Commissioners that the Public Building Commission implemented the second phase of planning, designing and constructing a large-scale energy retrofit program for the Metropolitan Water Reclamation District of Chicago.

Following discussion and comment, the Executive Director's report was accepted.

The next item on the agenda was consideration of approval to award Contract #1600 for

the Wendell Phillips Academy High School Annex located at 244 East Pershing Road to Burling Builders, Inc. Five (5) sealed bids were received from duly pre-qualified general contractors deemed eligible to bid as a result of the bid solicitation. Upon motion duly made and seconded, the following resolution was adopted:

WHEREAS, as a part of its bid proposal, Burling Builders, Inc. has advised the Commission that the surety on the performance and payment bond to be supplied in the form set forth in the contract documents will be Travelers Casualty and Surety Company of America, corporate surety, authorized to do business under the laws of the State of Illinois; and

**WHEREAS**, the staff of the Commission has recommended that Contract No. 1600 be awarded to Burling Builders, Inc. and that Travelers Casualty and Surety Company of America, the proposed surety on the performance and payment bond, be accepted and approved by the Commission.

**NOW THEREFORE BE IT RESOLVED** that the Board of Commissioners hereby awards to Burling Builders, Inc. Contract No. 1600 Wendell Phillips Academy High School Annex Project, pursuant to the terms thereof for the total contract price of \$12,439,000.00, and authorizes and directs the appropriate officers of the Public Building Commission of Chicago to take such action as may be required or advisable in order to consummate the award and to execute the contract.
