CONTRACTOR SHALL CLEAN DUCTWORK AND TEST FAN AND HEATER FOR OPERATION AND PROVIDE SUMMARY OF DEFICIENCIES, IF ANY. THE FOLLOWING MINIMUM REPAIR SCOPE SHALL BE INCLUDED IN THE BASE BID: CLEAN FAN OF ALL DEBRIS, REPLACE BELT AND SHEAVE AND GREASE BEARINGS FOR PROPER OPERATION."
