The meeting was called to order by Chairman Johnson and the presence of a quorum was established.

Thereupon, a public participation period was conducted pursuant to Section 2.06(g) of the Open Meetings Act and the guidelines for comments established by Resolution No. 7611 approved by the Board of Commissioners on January 11, 2011. The following persons had previously registered to provide comments during the public participation period: Kenneth Newman; Zoe Leigh; Jessica Jackson; Teaira Conway; James McCoy; David Mason; and George

Blakemore. Kenneth Newman provided comments regarding the Kennedy King expansion project, use of vacant land at Daley College and the use of advertisements on public schools and parks to increase revenues so that additional athletic facilities could be built. Zoe Leigh provided comments regarding eminent domain in violation of the constitution. Jessica Jackson provided comments regarding the City of Chicago and Cook County, the need to respect the constitution and property taxes. Teaira Conway provided comments regarding an incident allegedly involving a vehicle that resulted in incarceration. James McCoy provided comments regarding the need to provide help to local businesses and empowerment of communities. George Blakemore provided comments regarding his concerns about the Christkindlmarket on the Daley Center Plaza.

Following the conclusion of the public participation period, the Commissioners were presented with consideration of approval of the minutes of the Regular Meeting of the Board of Commissioners held on November 12, 2024. The reading of said minutes, which had previously been distributed, was dispensed with and upon motion duly made and seconded, the minutes of the November 12, 2024 board meeting were unanimously approved.

The next item on the agenda was the administration of the Oath of Office to David Todd Whittley, appointee of the City of Chicago, as a Commissioner of the Public Building Commission for a term ending on September 30, 2029. The Oath of Office was administered to David Todd Whittley for a term ending September 30, 2029 by Chairman Johnson. Upon motion duly made and seconded, the following resolution was adopted:

The next item on the agenda was a report by Commissioner Maldonado regarding the

Administrative Operations (AO) Committee meeting held on December 4, 2024. Commissioner

Maldonado's report regarding the AO Committee meeting is summarized as follows:

The Director of Procurement reported on a task order award for Environmental Engineering and Environmental Renovation/Demolition Specialty Consultant Services to previously appointed firms.

The Director of Procurement provided the following reports:

- Appointment of a firm to provide Design Build Services for the City of Chicago School of Nursing Expansion Project at Kennedy King College located at 6301 S. Halsted Street.
- Report on Bid Opening for Contract C1615 for the Forest Preserve District of Restroom Rehabilitation Project at Busse Woods and Dan Ryan Woods.
- Report on Bid Opening for Contract C1616 for the Works Progress Administration (WPA) Street Reconstruction Project (East 109<sup>th</sup> Street, South Hoyne Avenue, South Harding Avenue and East 102nd Street).

The Executive Director reported on Field Orders and various outreach opportunities.

The AO Committee accepted the recommendations and reports from the PBC representatives.

A copy of the Task Order Report is attached hereto as Exhibit "A".

The next item on the agenda was a report by the Executive Director regarding regular reports, development status and other matters. He provided the Commissioners with updates regarding the following Public Building Commission activities and events that have occurred since the last Board Meeting. The Public Building Commission issued its external newsletter, "Constructive News You Can Use" which shared progress made during the final quarter of 2024.

On November 15, 2024, the Public Building Commission was joined by Chairman Johnson, Commissioner Whittley, the City Colleges of Chicago, elected officials, community leaders, faculty and students at the groundbreaking ceremony for the new community center for teaching and learning at Malcolm X College – West Campus located at 4624 W. Madison Street. The new addition will create approximately 7,000 square feet of usable space and provide additional recreational and student and community meeting spaces and academic support space for enhanced learning. Executive Director Giderof expressed appreciation to Commissioner Whittley for attending the event. Other notable events reported by Executive Director Giderof during his report included the following:

- On November 15 and November 20, 2024, the Public Building Commission hosted in-person community hiring events for the Lincoln Square Brown Line Area Improvements Projects at the Sulzer Regional Library located at 4455 N. Lincoln Avenue and the Budlong Woods Library located at 5630 N. Lincoln Avenue;
- On November 20, 2024, the Public Building Commission attended the Chicago Minority Supplier Development Council General Meeting along with the City of Chicago's Chief Procurement Officer and representatives from the Illinois Tollway. This event enabled the Public Building Commission to provide information about current projects and future construction and professional opportunities;
- On December 9, 2024, the Public Building Commission hosted a community hiring event at the Bauer Plummer Public Safety Center located at 4417 West Chicago Avenue for the new Emergency Medical Services (EMS) project. A second hiring event for the project is scheduled for December 19, 2024, at the Legler Library located at 115 S. Pulaski Road.

At the conclusion of his report, Executive Director Giderof expressed appreciation for the leadership, courage and guidance of the Commissioners throughout the year and extended holiday greetings to everyone. Thereupon, the report by the Executive Director was accepted.

The next item on the agenda was consideration of approval to award Contract C1616 for the Works Progress Administration (WPA) Street Reconstruction (East 109<sup>th</sup> Street, South Hoyne Avenue, South Harding Avenue and East 102<sup>nd</sup> Street) (the "Project"). On December 3, 2024, sealed bids were received from five (5) contractors. Following a review of the bid documents, it was recommended that Contract C1616 be awarded to Sumit Construction Company, Inc. Upon motion duly made and seconded, the following resolution was adopted:

WHEREAS, as a part of its bid proposal, Sumit Construction Company, Inc. has advised the Commission that the surety on the performance and payment bond to be supplied in the form set forth in the contract documents will be Travelers Casualty and Surety Company of America, corporate surety, authorized to do business under the laws of the State of Illinois; and

**WHEREAS,** the staff of the Commission has recommended that Contract C1616 be awarded to Sumit Construction Company, Inc. and that Travelers Casualty and Surety Company of America, the proposed surety on the performance and payment bond, be accepted and approved by the Commission.

**NOW, THEREFORE BE IT RESOLVED,** that the Board of Commissioners hereby awards to Sumit Construction Company, Inc. The next item on the agenda was consideration of approval of a firm to provide Design

Build Services for the City Colleges of Chicago School of Nursing Expansion project at 6301

South Halsted Street (the "Project"). Executive Director Giderof advised the Commissioners that

the PBC in collaboration with the City Colleges of recommended the appointment of Burling

Builders, Inc., a minority-owned firm in collaboration with BeeHyyve and JGMA, both certified Minority Business Enterprise firms (Burling BeeHyyveJGMA) as the Design Builder for the Project. This recommendation was the result of PBC's One-Step Design-Build Process following the advertisement and notification requirements. Six (6) submissions were received from firms interested in providing the required services the Project. An Evaluation Committee comprised of knowledgeable and experienced staff from the City Colleges of Chicago and the Public Building Commission reviewed the submissions based upon the following criteria: technical qualifications; past performance; key personnel and consultants; utilization goals; cost and financials; references; interview; and responsiveness to the Request for Proposals (RFP). After an initial evaluation of the submissions, three (3) firms were invited for interviews. Following the interviews, it was the consensus of the Evaluation Committee to appoint Burling BeeHyyve JGMA as the Design Builder for the Project. Burling BeeHyyve JGMA has committed to work with diverse and experienced trade subcontractors, student engagement and hiring as well as sponsoring students into the union within thirty days of the Notice to Proceed. Upon motion duly made and seconded, the following resolution was approved:

#### **RESOLUTION NO. 8760**

**BE IT HEREBY RESOLVED** that the Board of Commissioners of the Public Building Commission hereby appoints Burling Builders Inc., a minority owned firm, in collaboration with BeeHyyve and JGMA, both certified Minority Business Enterprise (Burling BeeHyyveJGMA), as Design Builder for the City Colleges of Chicago School of Nursing Expansion Project located at 6301 South Halsted Street. The PBC will negotiate a Guaranteed Maximum Price (GMP) to complete the design and construction of the Project within the total approved budget.

**BE IT FURTHER RESOLVED** that the Executive Director and appropriate officials of the Public Building Commission are hereby authorized and directed to undertake such actions and, upon approval by Legal Counsel as to form and legality, execute such documents as may be necessary in order to effectuate this Resolution.

The Public Building Commission of Chicago (PBC) issued a Request for Proposal (RFP) to **Environmental Design International Inc.** who has been pre-qualified to provide Environmental Engineering Services: Construction Oversight, as required at the above-named Project. We have reviewed the proposal submitted to perform the following environmental services:

- (i). Soil Removal Oversight Services;
- (ii). Construction Meetings;

On May 29, 2024, (updated on August 25, 2024 to include roof sample scope) GSG submitted a proposal including an Attachment Fee Schedule of hourly Rates for varying job titles which has been approved by PBC. The amount for this contract is being issued as a not-to-exceed amount of \$198,490, to complete the scope of work and \$39,698 in contingency costs, for a total proposed amount of \$238,188.

Based on the review, we recommend that GSG be selected to complete the work, due to the following:

- They are capable and have performed Services for similar projects.
- Provided a clear understanding of the project requirements;
- Project management and staffing plan;
- Provided fair and reasonable pricing;
- They have extensive experience in the activities described in the RFP;
- They are a PBC pre-qualified specialty consultant to perform these services;
- Consultant is committed to comply with the PBC's MBE/WBE Goals.

GSG should be assigned a Task Order, in the not-to-exceed amount of \$198,490, with \$39,698 in contingency, for a total of \$238,188.
