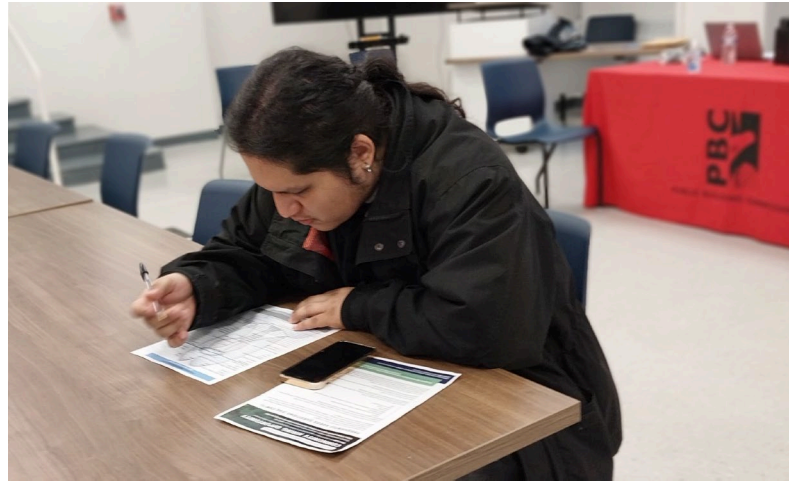

WESTERN BROWN LINE AREA IMPROVEMENTS

PRE-CONSTRUCTION MEETING

The Public Building Commission, in collaboration with the Department of Transportation, will begin work on renovating the area around the Western Brown Line station. Based on years of community meetings and engagement, this work will involve the renovation of the pedestrian plaza, the adjacent parking lot, and the pedestrian path under the El tracks from Lincoln to the CTA station. It will also include traffic calming in the form of a raised intersection at Lincoln & Leland, a protected bike lane on Leland, and a refuge island and traffic diverter at Leland & Western.
