Thereupon, a public participation period was conducted pursuant to Section 2.06(g) of the Open Meetings Act and the guidelines for comments established by Resolution No. 7611 approved by the Board of Commissioners on January 11, 2011. The following persons had

previously registered to provide comments during the public participation period: George Blakemore; Zoe Leigh; Danielle Carter; and Kenneth Newman. George Blakemore provided comments regarding immigration and contracts for black people. Zoe Leigh provided comments regarding generational wealth for black people and First Amendment rights of citizens. Danielle Carter provided comments regarding First Amendment rights of citizens and immigration. Kenneth Newman provided comments urging the construction of additional athletic facilities on vacant property adjacent to public schools at various locations in the City of Chicago.

Following the conclusion of the public participation period, the Commissioners were presented with consideration of approval of the minutes of the Regular Meeting of the Board of Commissioners held on January 14, 2025. The next item on the agenda was a report by Commissioner Maldonado regarding the Administrative Operations (AO) Committee meeting held on February 5, 2025. Commissioner Maldonado's report regarding the AO Committee meeting is summarized as follows:

The Executive Director provided a report on a Specialty Consultant task order award for Survey Services to a previously appointed firm.

The Executive Director also provided reports on Bid Openings for Contract C1618 and Contract C1619 for the Works Progress Administration (WPA) Street Reconstruction Projects and Contract C1613 for the Forest Preserve District of Cook County Metal Buildings – McGinnis Field Station Project.

The Executive Director also reported on Field Orders and various outreach opportunities.

The AO Committee accepted the recommendations and reports from the Executive Director.

A copy of the Task Order Report is attached hereto as **Exhibit “A”**.

The next item on the agenda was a report by the Executive Director regarding regular reports, development status and other matters. He provided the Commissioners with updates regarding the following Public Building Commission activities and events that have occurred since the last Board Meeting. Notable events reported by Executive Director Giderof during his report included the following:

- On January 16, 2025, the Public Building Commission hosted its Fifth Assist Agency Conference during which there were engaging conversations with the Executive Director of the Federation of Women Contractors, the Director of Business Development from Hire 360, the Director of Program Development for the Chicago Minority Supplier Development Council, the Director of Program Development for HACIA, the President of National Able Network and the President of V-E Solutions. This conference was in furtherance of the Public Building Commission’s mission to engage and assist agencies in developing relationships and collaborating on strengthening partnerships that benefit minority and women-owned businesses.
- On January 30, 2025, the Public Building Commission attended the Government Procurement Compliance (GPC) Forum at City Hall. The mission of the GPC is to make the region the benchmark for procurement certification and compliance processes that are streamlined, equitable and transparent. During the Forum, Congressman Jonathan L. Jackson provided information regarding the impact of diversity, equity and inclusion on local businesses.

- On February 24, 2025, the Public Building Commission, in partnership with the Chicago Department of Transportation, the Department of Planning and Development and the 35th Ward aldermanic office will host a community open house at the Avondale Logandale Elementary School located at 3212 West George Street to discuss public space development opportunities for the Logan Square Plaza Project. This event will be the third (3rd) community engagement meeting for the Project and will provide an opportunity for residents to share feedback and engage with the team.
- Finally, the Executive Director provided remarks regarding the celebration of Black History Month during which the achievements of African Americans have been shared in recognition of their prominent role in United States history.

Thereupon, the report by the Executive Director was accepted.

The next item on the agenda was consideration of approval of a Partial Undertaking Request from the City of Chicago for the Department of Water Management Lead Service Line Replacement Program (the “Project”). Executive Director Giderof advised the Commissioners that the City of Chicago Department of Water Management (DWM) and the Office of Budget and Management (OBM) have requested approval of a Partial Undertaking to provide development services which may include administrative, technical, professional and legal services in support of the Project as well as coordination and management of planning (if necessary), design (if necessary) and construction on behalf of DWM. The funding authority included in the Partial Undertaking is not-to-exceed \$750M, which will be coordinated by DWM in conjunction with DWM. OBM will advise of any requirements associated with funding sources, including grant requirements. Following approval of the Partial Undertaking Request, the Public Building Commission will continue to work with DWM to coordinate the initial phase(s) of the Project.

The next item on the agenda was consideration of approval of a Partial Undertaking Request from the City of Chicago for the Department of Family and Support Services Regional Senior Center Project located at 4711 – 4755 South Calumet Avenue (the “Project”). The Commissioners were advised by the Executive Director that the City of Chicago Department of Fleet and Facility Management (2FM), the Department of Family and Support Services (DFSS) and the Office of Budget and Management (OBM) have requested approval of a Partial Undertaking in the amount of \$2,000,000 to provide for the development of a new Regional Senior Center including community and administrative spaces along with site improvements in support of DFSS’ senior programming. The scope of services associated with this Partial Undertaking includes, but is not limited to planning, due diligence, design, pre-construction and

associated management services in support of the Project. Following approval of the Partial Undertaking, the Public Building Commission will work collaboratively with 2FM and DFSS to confirm the scope, program, budget and schedule that can be accommodated within the anticipated available funding. OBM will coordinate the funding requirements for the Project and advise of any requirements associated with funding sources, including grant requirements.

In 2023, the PBC publicly advertised Requests for Qualifications (RFQ) from firms interested in providing consulting services in the following categories: Surveyor Services, among others. In November 2023, the PBC received approval to award term contracts to firms pre-qualified to provide specialty consulting services in this category among others.
